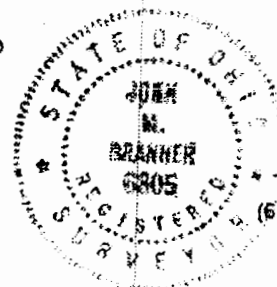

DESCRIPTION OF A 5.00 ACRE TRACT

Situated in Sections 2 of T.10, R14, Dover Township and Section 32 of T.9, R.13, Ames Township, and being a part of a 24.743 acre tract as described in Volume 153, Page 795 of the Official Records of Athens County, and being more particularly described as follows:

Commencing at the South-west corner of Section 32, of Ames Township, thence, East, 18.4 chains (deed) to an iron pin; thence, North 21 Degrees 54 Minutes 09 Seconds West, 913.45 feet to a point in County Road 26; thence, along said road, South 85 Degrees 33 Minutes 19 Seconds West, 152.05 feet to a point; thence, thence South 70 degrees 34 minutes 20 seconds West, a distance of 223.52 feet;

thence South 54 degrees 39 minutes 20 seconds West, a distance of 38.24 feet; thence continuing South 54 Degrees 39 Minutes 20 Seconds West, along said line, a distance of 188.07 feet to the POINT OF BEGINNING;

thence, leaving said road, South 60 degrees 28 minutes 15 seconds East, a distance of 282.64 feet;

thence South 39 degrees 13 minutes 00 seconds West, a distance of 592.87 feet to a railroad spike in Township Road 218;

thence, along said road, North 79 degrees 10 minutes 47 seconds West, a distance of 96.71 feet to a railroad spike;

thence South 84 degrees 57 minutes 34 seconds West, a distance of 110.40 feet to a railroad spike;

thence South 76 degrees 22 minutes 44 seconds West, a distance of 183.41 feet to a railroad spike in the intersection of Township Road 218 with County Road 26;

thence, along County Road 26, North 14 degrees 29 minutes 09 seconds East, a distance of 83.18 feet to a rail road spike;

thence North 29 degrees 00 minutes 40 seconds East, a distance of 136.97 feet to a railroad spike;

thence North 36 degrees 49 minutes 30 seconds East, a distance of 186.12 feet to a railroad spike;

thence North 51 degrees 48 minutes 00 seconds East, a distance of 217.03 feet to a rail road spike;

thence North 43 degrees 37 minutes 00 seconds East, a distance of 206.99 feet to the POINT OF BEGINNING; said described tract containing 5.000 acres.

Subject to all easements and rights of way of record.

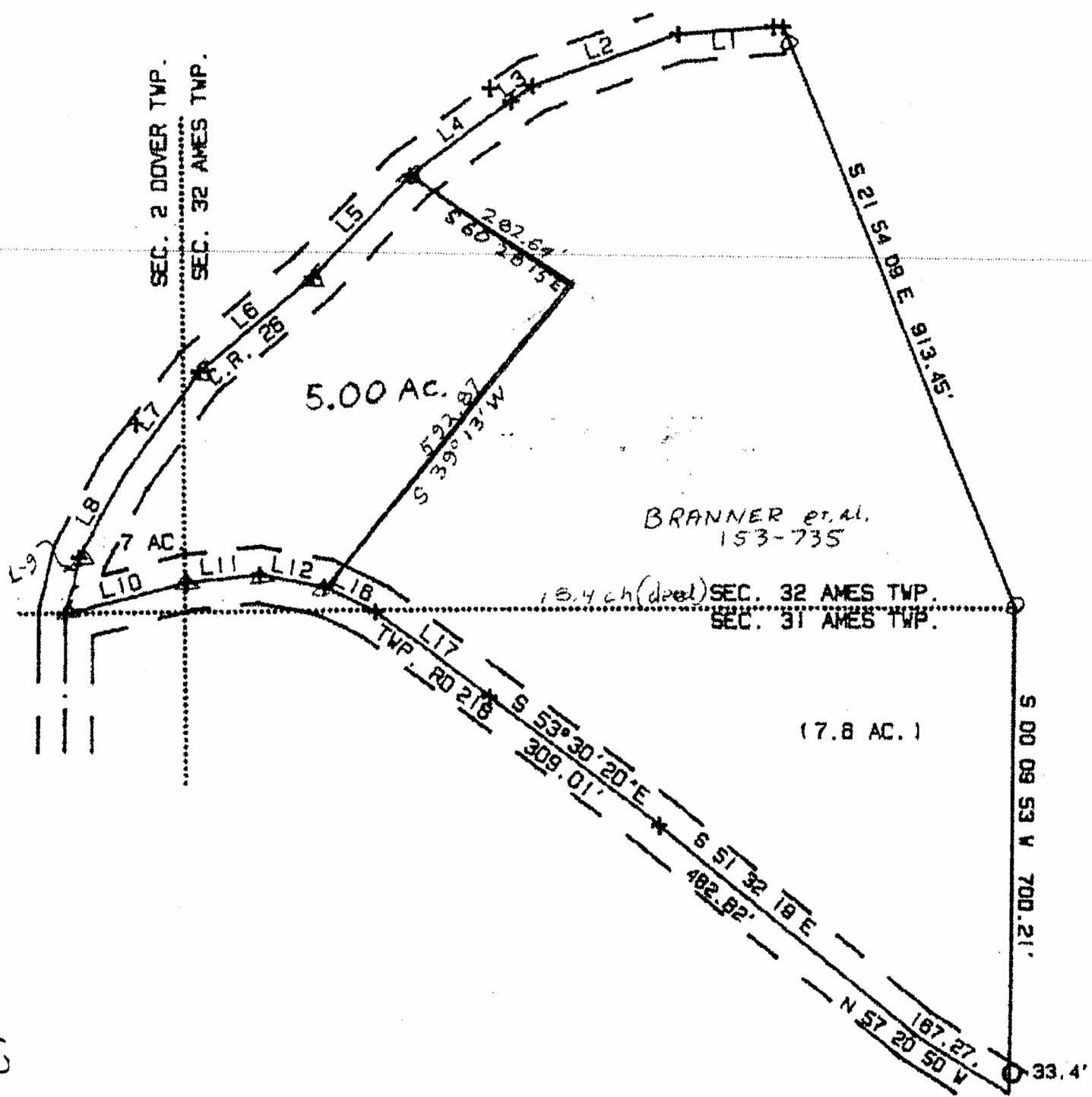
