Commencing at the northeast corner of said Section 20; thence along the east line of said Section 20 on an assumed bearing of South 0 degrees 27 minutes 38 seconds West, a distance of 363.69 feet to an iron pin* on the north line of a 30 acre tract described in Volume 127 Page 812 of the Athens County Official Deed Records; thence along the north line of the said 30 acre tract South 89 degrees 15 minutes 38 seconds West, a distance of 1065.32 feet to a found iron pin; thence continuing along the north line of the said 30 acre tract South 89 degrees 15 minutes 31 seconds West, a distance of 281.38 feet to a set iron pin, THE TRUE POINT OF BEGINNING; thence leaving the north line of said 30 acre tract South 0 degrees 43 minutes 42 seconds East, a distance of 319.63 feet to a set iron pin; thence South 89 degrees 15 minutes 39 seconds West, a distance of 370.37 feet to a set iron pin; thence South 0 degrees 43 minutes 42 seconds East, a distance of 22.00 feet to a set iron pin; thence South 89 degrees 16 minutes 18 seconds West (passing a found iron pin at 25.00 feet, the northeast corner of a 0.72 acre tract described in Volume 152 Page 346 of the Athens County Official Deed Records) for a total distance of 100.00 feet to a found iron pin, the southeast corner of a 0.95 acre tract described in Volume 163 Page 329 of the Athens County Official Deed Records; thence along the east line of said 0.95 acre tract North 1 degrees 18 minutes 23 seconds West, a distance of 120.03 feet to a found iron pin; thence continuing along the east line of said 0.95 acre tat North 3 degrees 14 minutes 24 seconds West, a distance of 209.65 feet to a found iron pin on the south line of an unimproved alley; thence along the south line of said unimproved alley North 89 degrees 13 minutes 41 seconds East, a distance of 123.69 feet to a set iron pin on the east end of said unimproved alley; thence along the east end of said unimproved alley North 0 degrees 44 minutes 22 seconds East, a distance of 12.07 feet to a found iron pin; thence along the north line of the aforesaid 30 acre tract North 89 degrees 15 minutes 39 seconds East, a distance of 356.77 feet to the point of beginning and containing 3.5000 acres, and being a part of a 30 acre tract described in Volume 127 Page 812 of the


Athens County Official Deed Records, said tract was surveyed by John Branner P.S. 6805 in July of 1993 and contained 29.48 acres.


