Thence along the west line of the 0.21 acre tract South 40 degrees 48 minutes 22 seconds West a distance of 356.44 feet to a 5/8" iron pin with a plastic identification cap set on the southwest corner of a 0.29 acre tract as recorded in Deed Book 362 at page 425 and Deed Book 383 at page 529;

Thence with a new line, North 49 degrees 11 minutes 31 seconds West a distance of 375.16 feet to a 5/8" iron pin with a plastic identification cap set;




