Thence, South 1 degree 31 minutes 52 seconds West 1629.53 feet to a point in the U.S. Route 33 right-of-way, said point being North 1 degree 31 minutes 52 seconds East 50.00 feet from an iron pin (found);

Thence, North 86 degrees 30 minutes 12 seconds East 1800.02 feet to a point in the U.S. Route 33 right-of-way;

Thence, South 63 degrees 18 minutes 58 seconds East 150.00 feet to a point in the U.S. Route 33 right-of-way;

Thence, North 67 degrees 55 minutes 21 seconds East 696.13 feet to a 3/4 inch iron pipe (set);

Thence, North 86 degrees 59 minutes 58 seconds West 374.99 feet to a 3/4 inch iron pipe (set);

Thence, North 88 degrees 43 minutes 00 seconds West 205.00 feet to a 3/4 inch iron pipe (set);

Thence, North 56 degrees 14 minutes 59 seconds West 888.49 feet to an old stone (found);

Thence, North 6 degrees 51 minutes 35 seconds East 247.66 feet to an iron pin (found);

Thence, North 15 degrees 02 minutes 12 seconds West 487.33 feet to an iron pin (found);

Thence, North 35 degrees 00 minutes 00 seconds West 66.94 feet to an iron pin (found);

Thence, North 88 degrees 06 minutes 21 seconds West 1079.41 feet to the point of beginning, containing 54.158 acres more or less,

Excepting 0.35 acres more or less owned by the C & O RR Co (reference V 82, P 476 Record of Deeds, Athens Co.) and being described as follows:

Beginning at a point on the north R/W of U.S. 33 (40' from center line) where the North R/W of the C & O R R intersects, which is N 89 44' E (along the north line of Section 25) 2936.7' and S O 16' E 187.3' from iron pin at the Northwest corner of Section 25; thence along the North R/W (20' from the center line) N 87 05' W 74.8'; thence with a curve left radius 975.37' a distance of 356.1'; thence S 71 58' W 103.2' more or less to the North R/W of US 33; thence with R/W of US 33 N 86 30' E 64.0' more or less; thence by a curve left radius 2506.5' a distance of 109.5' more or less to intersection of C & O RR South R/W; thence with C & O R/W curve right radius 935.37' a distance of 190.0' more or less to intersection U.S. 33 R/W; thence by a curve left with US 33 R/W radius 2506.5' a distance of 166.0' more or less to the place of beginning, and being in Section 25;
