thence, leaving said Section lines, South 3 degrees 48 minutes 04 seconds West, a distance of 1320.46 feet to a found stone;

thence, North 86 degrees 15 minutes 15 seconds West, a distance of 670.70 feet to an iron pin set;

thence, North 3 degrees 48 minutes 04 seconds East, a distance of 1320.00 feet to an iron pin set on the aforementioned Section lines;

thence, North 2 degrees 04 minutes 20 seconds East, a distance of 52.82 feet to a point in an existing road;

thence, following said road, North 6 degrees 26 minutes 28 seconds East, a distance of 105.01 feet to a point, referenced by an iron pin set Bearing South 26 degrees 23 minutes 38 seconds East, a distance of 19.18 feet;

thence, North 6 degrees 50 minutes 36 seconds West, a distance of 116.15 feet to a point;

thence, North 23 degrees 31 minutes 32 seconds West, a distance of 81.77 feet to a point;

thence, North 20 degrees 51 minutes 10 seconds West, a distance of 85.97 feet to a point, referenced by an iron pin set Bearing South 59 degrees 07 minutes 01 seconds East, a distance of 18.36 feet;

thence, North 52 degrees 43 minutes 09 seconds West, a distance of 273.69 feet to a point, referenced by an iron pin set Bearing North 01 degree 08 minutes 11 seconds East, a distance of 10.41 feet;

thence, North 41 degrees 21 minutes 29 seconds West, a distance of 43.49 feet to a point;

thence, North 6 degrees 25 minutes 48 seconds East, a distance of 216.87 feet to a point in County road 110, passing an iron pin set at 173.30 feet;

thence, following said road, North 73 degrees 49 minutes 00 seconds East, a distance of 156.35 feet to a point;

thence, North 86 degrees 16 minutes 00 seconds East, a distance of 41.39 feet to a Rail Road Spike found;






