## Legal Description 2.456 Acres

Situated in the Township of Dover, County of Athens, State of Ohio, and being a part of the Northeast Quarter of Section 21, Township 10N, Range 14W, and being more particularly described as follows;

Being a Survey of the residual of Parcel One (P.P.N. G01-00100652-02) and part of Parcel Two (P.P.N. G01-00100705-01) conveyed to Sanborn Properties, Ltd., as recorded in O.R. Book 389, Page 529, in the Athens County Deed Records, and further described as follows;

Commencing at the Northeast corner of Section 21;

Thence, S 02°18'41" W 550.15 feet with the East line of Section 21, to a point;

Thence, N 87°21'26" W 702.09 feet leaving said Section Line to a mag nail set in the centerline of Carr Hollow Road (Twp. Road 608), also being on the North line of a 1.501 Acre parcel conveyed to Nicholas L. & Shirley K. Carr, as recorded in O.R. Book 409, Page 1405, also being on the East line of an 8.17 Acre parcel conveyed to Evan E. Clark, as recorded in O.R. Book 468, Page 953, being the **PRINCIPLE PLACE OF BEGINNING** of the **2.456 Acre** parcel herein to be described, and passing over an iron rail found at 289.97 feet;

Thence with the centerline of Carr Hollow Road, with the following seven (7) courses and distances:

- 1) S 21°10'00" E 20.05 feet to a point;
- 2) S 34°09'51" E 51.28 feet to a point;
- 3) S 51°41'37" E 36.57 feet to a point;
- 4) S 70°54'20" E 34.29 feet to a point;
- 5) S 75°27'41" E 83.87 feet to a point;
- 6) S 75°14'41" E 158.75 feet to a point;
- 7) S 79°12'12" E 140.22 feet to a mag nail marking the centerline intersection of Carr Hollow Road and State Route 13;

Thence, S 43°14'22" W 359.71 feet with the centerline of State Route 13, to a point marking the Southeast corner of a 0.570 Acre parcel conveyed to the State of Ohio, as recorded in O.R. Book 93, Page 278;

Thence with the boundary of said 0.570 Acre parcel conveyed to the State of Ohio (OR93,Pg.278), with the following four (4) courses and distances:

- 8) N 46°59'44" W 44.36 feet to an iron pin set;
- 9) S 42°54'37" W 37.10 feet to an iron pin set;
- 10) S 62°51'11" W 105.15 feet to an iron pin set;
- 11) S 43°00'16" W 11.96 feet to an iron pin set on the East line of said parcel conveyed to Clark (OR468,Pg.953);

Thence with the East line of said parcel conveyed to Clark (OR468,Pg.953), with the following three (3) courses and distances:

- 12) With a curve to the left (Radius = 553.80 feet, Delta Angle 27°41'15", Arc Length 267.62 feet) with a chord bearing N 05°34'31" W 265.02 feet to an iron pin set at a point of tangency;
- 1) N 19°25'07" W 251.07 feet to a 5/8" o.d. iron pin found;
- 2) S 87°21'26" E 45.54 feet to the PRINCIPLE PLACE OF BEGINNING.

Said parcel as surveyed contains 2.456 Acres, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The above described 2.456 Acre parcel contains 1.011 Acres in P.P.N. G01-00100652-02 and 1.445 Acres in P.P.N. G01-00100705-01.


