2.501 Acre Parcel I

- 1) Being part of a 5 (+/-) Acre Tract (# G010010057600) owned by Kathleen Ann Matheny as specified in a "Transfer on Death Designation Affidavit" recorded in Official Record 486 at page 1056 in the Athens County Recorder's Office, Athens County, OH, and, being situate in the SW-1/4 of Section 33, Town-10-North, Range-14-West, Dover Township, Athens County, State of Ohio, USA, and being more particularly described as follows:


