Beginning for reference, and the principal place of beginning at an iron pin set at the northwest corner of Lot 13, of Sedalia, (now Glouster), as per Envelope 93C, and 93 D of the Athens County Recorders Records;

Thence along the south line of Spring Street, and the north line of Lots 13, and 12, South 85 degrees 51 minutes 36 seconds East, 100.00 feet to an iron pin set on the Northeast corner of Lot 12, and the northwest corner of lands presently owned by Jason Umo, (OR 79-618);

Thence along the east line of said Lot 12, and the west line of said Umo lands, South 04 degrees 08 minutes 25 seconds West, 74.54 feet to an iron pin set on the north line of State Route 13, (AKA Broad Street);
