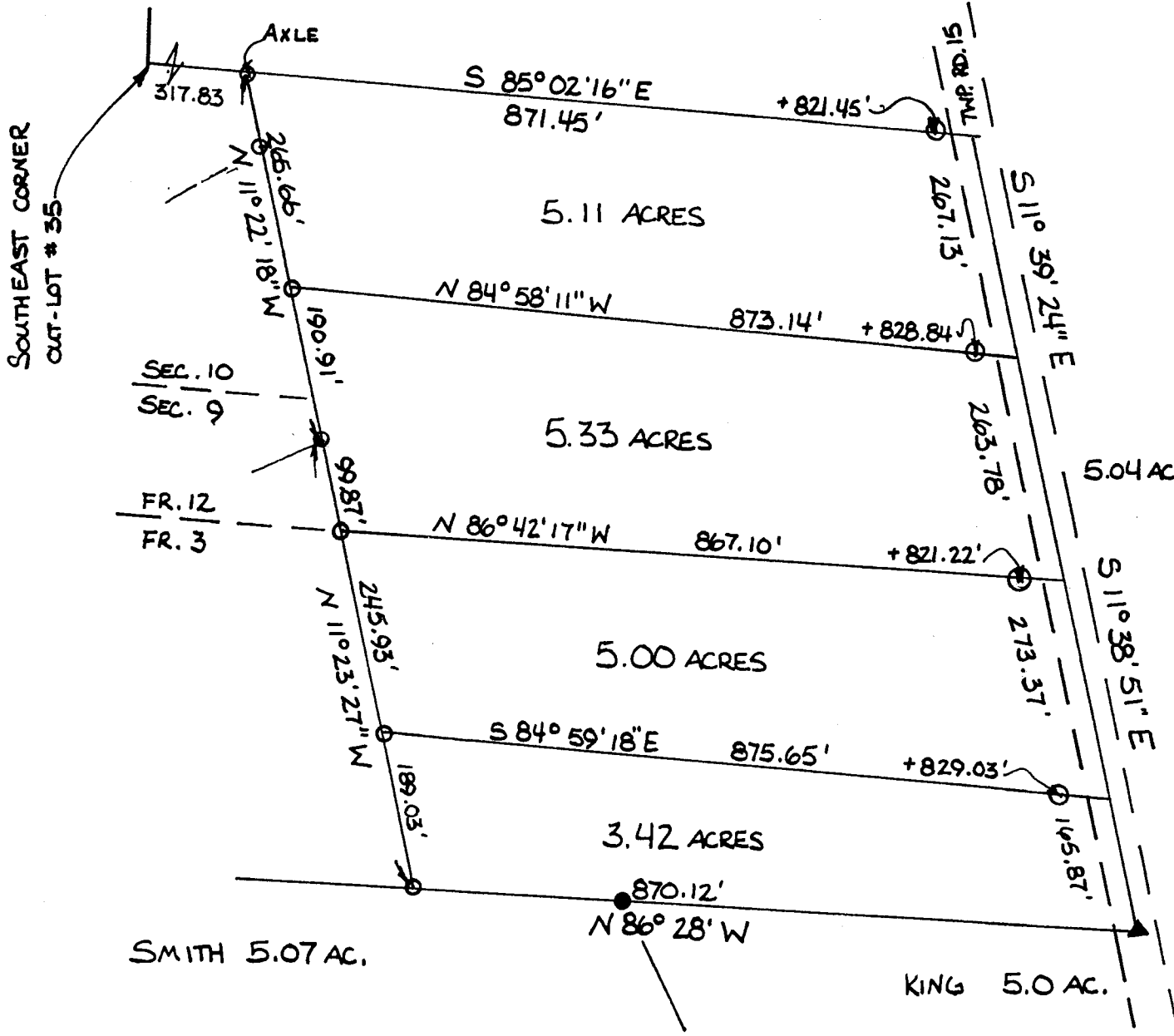

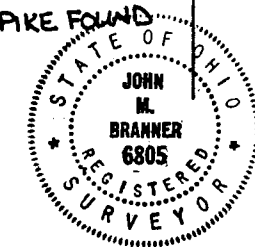

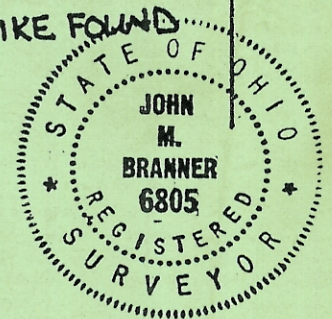
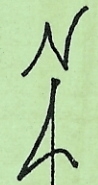
SOUTHEAST CORNER
