Situated in Outlots 24,25 and 35, Fraction 12, Section 10, Town 10, Range 15, Lee Township, Athens County, Ohio and described as follows:

Commencing at the northeast corner of said Fraction 12; thence on an assumed bearing North 85°59'48" West 1,558.93 feet to a point; thence South 04°00'12" West 310.00 feet to a found iron pin at the northwest corner of a 6.95 acre tract described in Volume 18 Page 717 of the Athens County Official Deed Records, said found iron pin is THE TRUE POINT OF BEGINNING; thence along the north line of said 6.95 acre tract South 84°21'49" East 512.80 feet to a point; thence on a random line South 02°44'28" East 265.50 feet to a set iron pin on the south line of said 6.95 acre tract and the north line of a 5.11 acre tract described in Volume 90 Page 190 of the Athens County Official Deed Records; thence along the south line of said 6.95 acre tract and north line of said 5.11 acre tract South 85°01'40". East 90.00 feet to a set iron pin; thence on a random line the following two bearings and distances:

- 1) South 02°44'28" East 170.70 feet to a set iron pin; thence
- 2) South 84'58'11" East (passing a set iron pin at 537.94 feet) for a total distance of 582.94 feet to a point in Athens County Road 12; thence along said road South 11°34'28" East 90.00 feet to the southeast corner of the aforesaid 5.11 acre tract; thence leaving said road and along the south line of said 5.11 acre tract North 84°58'11" West (passing a set iron pin at 44.30 feet) for a total distance of 872.81 feet to a found iron pin at the southwest corner of said 5.11 acre tract; thence along the west line of said 5.11 acre tract North 11°24'50" West 265.94 feet to a found iron pin at the northwest corner of said 5.11 acre tract; thence along the south line of the aforesaid 6.95 acre tract North 84°58'42" West 317.51 feet to a found iron pin at the southwest corner of said 6.95 acre tract; thence along the west line of said 6.95 acre tract North 04°00'12" East 268.81 feet to the point of beginning and containing 6.128 acres, there being 3.221 acres out of a 6.95 acre tract described in Volume 18 Page 717 of the Athens County Official Deed Records and 2.
