Situated in the northeast quarter of Section 13, Town 10, Range 15, Lee Township, Athens County, Ohio and described as follows:

Commencing at a fence corner, the approximate location of the northeast corner of said Section 13; thence along the east line of said Section 13, the east line of the grantor, the west line of a 7.9 acre tract described in Volume 329 Page 725 of the Athens County Deed Records and the west line of a 0.501 acre tract described in Volume 303 Page 31 of the Athens County Deed Records on an assumed bearing of South 3 degrees 57 minutes 27 seconds West (passing a found iron pin at 694.25 feet, the northwest corner of the aforesaid 0.501 acre tract) for a total distance of 942.85 feet to a point in the south right of way line of Athens County Road 12 and the north right of way of U.S. Route 50; thence along the said right of way South 60 degrees 32 minutes 54 seconds West, a distance of 90.23 feet to a point; thence leaving the said right of way North 3 degrees 57 minutes 27 seconds East (passing a set iron pin at 87.66 feet) for a total distance of 163.78 feet to a set iron pin; thence North 17 degrees 30 minutes 47 seconds West, a distance of 213.72 feet to a set iron pin; thence North 26 degrees 46 minutes 19 seconds West, a distance of 143.00 feet to a set iron pin; thence North 19 degrees 07 minutes 47 seconds West, a distance of 550.59 feet to a set iron pin on the north line of the grantor and the south line of a 51.58 acre tract described in Volume 38 Page 929 of the Athens County Official Deed Records; thence along the north line of the grantor and the south line of said 51.58 acre tract South 86 degrees 06 minutes 00 seconds East, a distance of 442.52 feet to the point of beginning and containing 5.1915 acres, and being a part of a 77 acre tract described in Volume 368 Page 697 of the Athens County Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


