Commencing at a found onehalf inch rebar (calculated location) at the Northeast corner of the West half of the West half of the Southeast quarter of said Section 17; thence North 89°59'34" West 1,426.93 feet to a point in the center of State Route 681; thence along the center of said State Route 681 South 27°10'15" East 675.02 feet to a railroad spike (calculated location) at the northwest corner of the grantor's 5.00 acre tract described in Volume 372 Page 251 of the Athens County Deed Records, said railroad spike is THE TRUE POINT OF BEGINNING; thence along the northerly line of said 5.00 acre tract and the south line of a sixty foot wide private easement for ingress and egress referred to in the plat of THE HARRY ROSS SUBDIVISION in the plat of records of the Recorder's Office of Athens County ,Ohio North 62°50'00" East (passing a found iron pin at 21.00 feet) for a total distance of 405.76 feet to a found iron pin at the northeast corner of said 5.00 acre tract; thence leaving said south line of said easement and along the easterly line of said 5.00 acre tract South 22°09'47" East 166.31 feet to an iron pin set; thence leaving said easterly line of said 5.00 acre tract on a random line South 62°50'00" West (passing a set iron pin at 370.25 feet) for a total distance of 391.25 feet to a point in the center of aforesaid State Route 681; thence along the center of saidaroad North 27°10'00" West 165.67 feet to the point of beginning and contain-1.516 acres and being a part of 5.00 acre tract described in Volume 372 Page 251 of the Athens County Deed Records.


