Situated in the southeast quarter of the northeast quarter of Section 2, Town 10, Range 15, Village of Albany, Lee Township, Athens County, Ohio and described as follows:

Commencing at the northeast corner of the southeast quarter of the northeast quarter of said Section 2; thence along the north line of said southeast quarter of the northeast quarter North 85 degrees 32 minutes 08 seconds West, a distance of 527.34 feet to an iron pin (calculated location), the northeast corner of a 5.44 acre tract described in Volume 48 Page 696 of the Athens County Official Deed Records; thence along the east line of said 5.44 acre tract South 5 degrees 28 minutes 46 seconds West, a distance of 423.41 feet to a found iron pin at southeast corner of said 5.44 acre tract and the grantor's northeast property corner; thence along the grantor's east property line South 5 degrees 28 minutes 43 seconds West, a distance of 228.28 feet to an iron pin set, THE TRUE POINT OF BEGINNING; thence continuing South 5 degrees 28 minutes 44 seconds West along said line, a distance of 251.16 feet to a found iron pin at the grantor's southeast property corner and the northeast corner of a 2.037 acre tract described in Volume 181 Page 812 of the Athens County Official Deed Records; thence along the grantor's south property line and the north line of said 2.037 acre tract North 87 degrees 04 minutes 22 seconds West, a distance of 220.12 feet to an iron pin (calculated location) at the grantor's southwest property corner and the northwest property corner of said 2.037 acre tract; thence along the grantor's westerly property line and along an arbitrary line North 5 degrees 34 minutes 56 seconds Bast, passing an iron pin (calculated location) at 108.01 feet, for a total distance of 205.71 feet to an iron pin set; thence along an arbitrary line the following five bearings and distances: 1) South 84 degrees 14 minutes 43 seconds East, a distance of 24.08 feet to an iron pin (calculated location); thence 2) North 4 degrees 52 minutes 40 seconds East, a distance of 110.37 feet to an iron pin set; thence 3) South 62 degrees 12 minutes 59 seconds East, a distance of 42.98 feet to an iron pin set; thence 4) South 46 degrees 25 minutes 46 seconds East, a distance of 51,29 feet to an iron pin set; thence 5) South 81 degrees 03 minutes 42 seconds East, passing through an existing utility pole at 98.79 feet, for a total distance of 116.70 feet to the POINT OF BEGINNING and containing 1.334 acres, and being a part of a tract described in Volume 53 Page 505 of the Athens County Official Deed Records.


