Thence S. 0° 32' 30" W. 158.00 feet to an iron pin on the South line of Sec. 19;

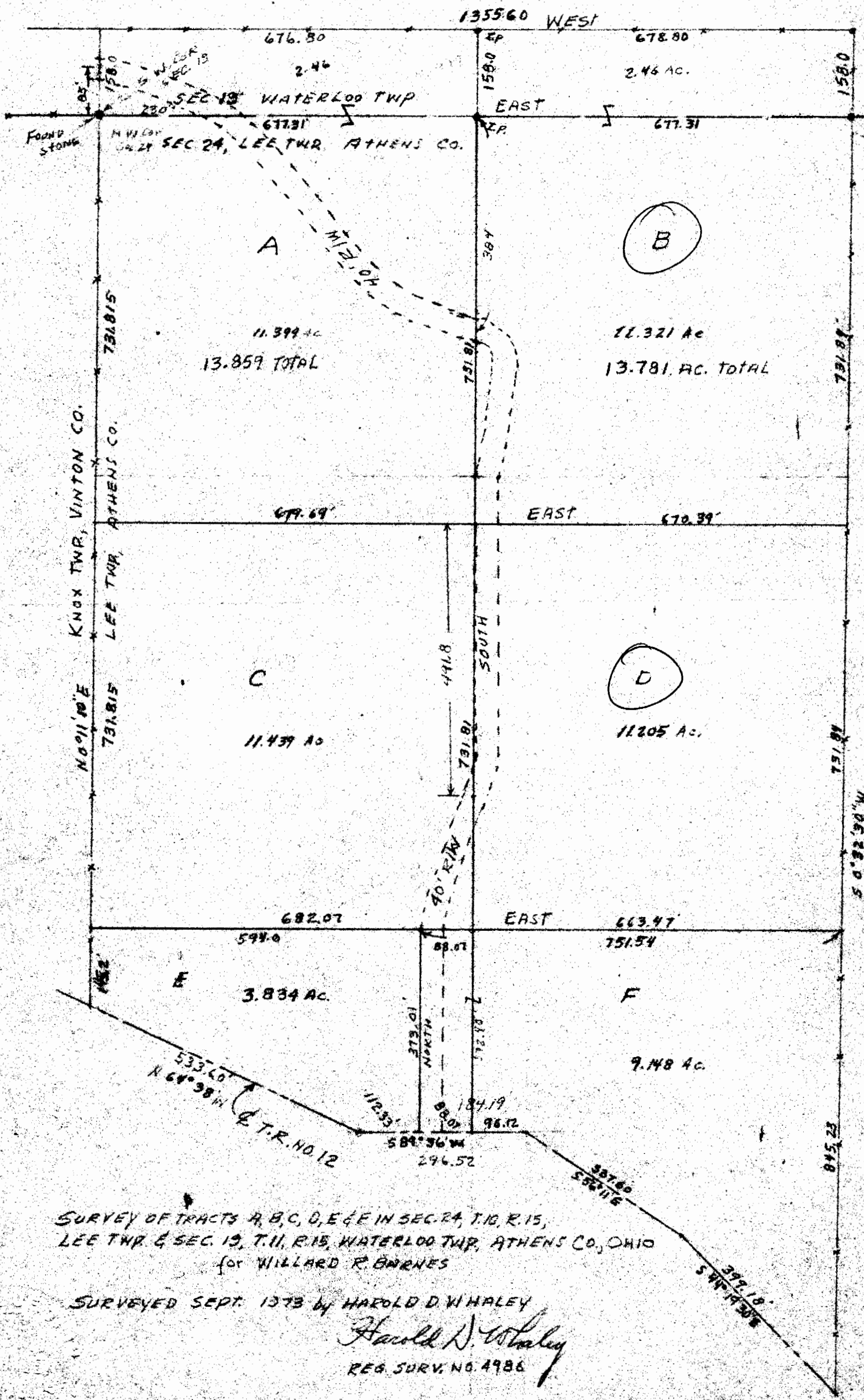
Thence along the South line of Sec. 19, WEST 677.31 feet to the point of beginning, containing 2.46 acres;
