
19) The above described "**242.279 Acre - New Legal Description**" totally encompasses the existing **Auditor's Parcels No. J010010000300, J010010008800, J010010008900, J010010009000, J010010009100, J010010009200 & J010010009301**, alleged to contain **33.21, 52.61, 14.90, 15.00, 65.50, 21.50 & 30.00 acres** respectively, making an alleged total of **232.72 acres**, as per Auditor's records and tract totals by deeds) and is intended to combine them into one (1) parcel to reflect the results of a new Property Survey to more accurately describe the subject premises and eliminate various inaccuracies and inadequacies that are present in the existing legal descriptions.

20) The bearings used in the above description are based on the said West line of the SW-1/4 of Section 7, the said East line of the SE-1/4 of Section 13, as bearing: **N 10°18'18" E** and are only for the determination of relative angles.

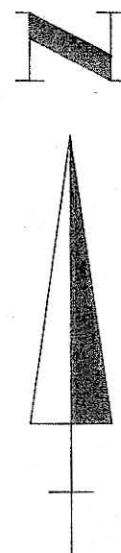
21) Subject to all legal highways and easements.
