Thence N. $56^{\circ} 27'$ E. (passing a stake at 182.28 feet, a stake at 241.84 feet) for a total distance of 361.66 feet to an iron pin;

Thence N. $52^{\circ} 02'$ E. (passing an iron pin at 55.42 feet, an iron pin at 172.61 feet) for a total distance of 309.81 feet to an iron pin;

Thence S. $83^{\circ} 03'$ E. (passing an iron pin at 27.70 feet) for a total distance of 209.40 feet to an iron pin;

Thence S. $80^{\circ} 44' 06''$ E., 289.75 feet to an iron pin;

Thence S. $47^{\circ} 53' 51''$ E., 126.32 feet to an iron pin;

Thence S. $38^{\circ} 55' 25''$ E., 99.33 feet to an iron pin;

Thence S. $31^{\circ} 41' 29''$ E., 142.19 feet to an iron pin on the West bank of Shade River;

Thence S. $58^{\circ} 03'$ E. (passing an iron pin at 53.88 feet) for a total distance of 79.78 feet to a R. R. spike in the centerline of T. R. No. 78;

Thence along the centerline of T. R. No. 78, S. $51^{\circ} 23'$ W., 75.09 feet to a R. R. spike;

Thence S. $66^{\circ} 32'$ W., 124.74 feet to a R. R. spike;

Thence S. $77^{\circ} 28'$ W., 182.85 feet to a R. R. spike;

Thence S. $69^{\circ} 59'$ W., 316.19 feet to a R. R. spike;

Thence S. $75^{\circ} 33'$ W., 319.02 feet to an iron pin;
Thence S. $1^{\circ} 07' 40''$ E., 115.85 feet to a R. R. spike;

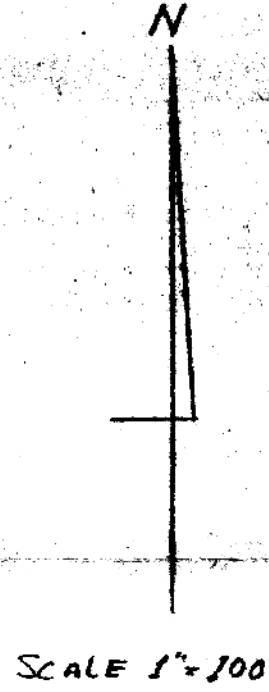
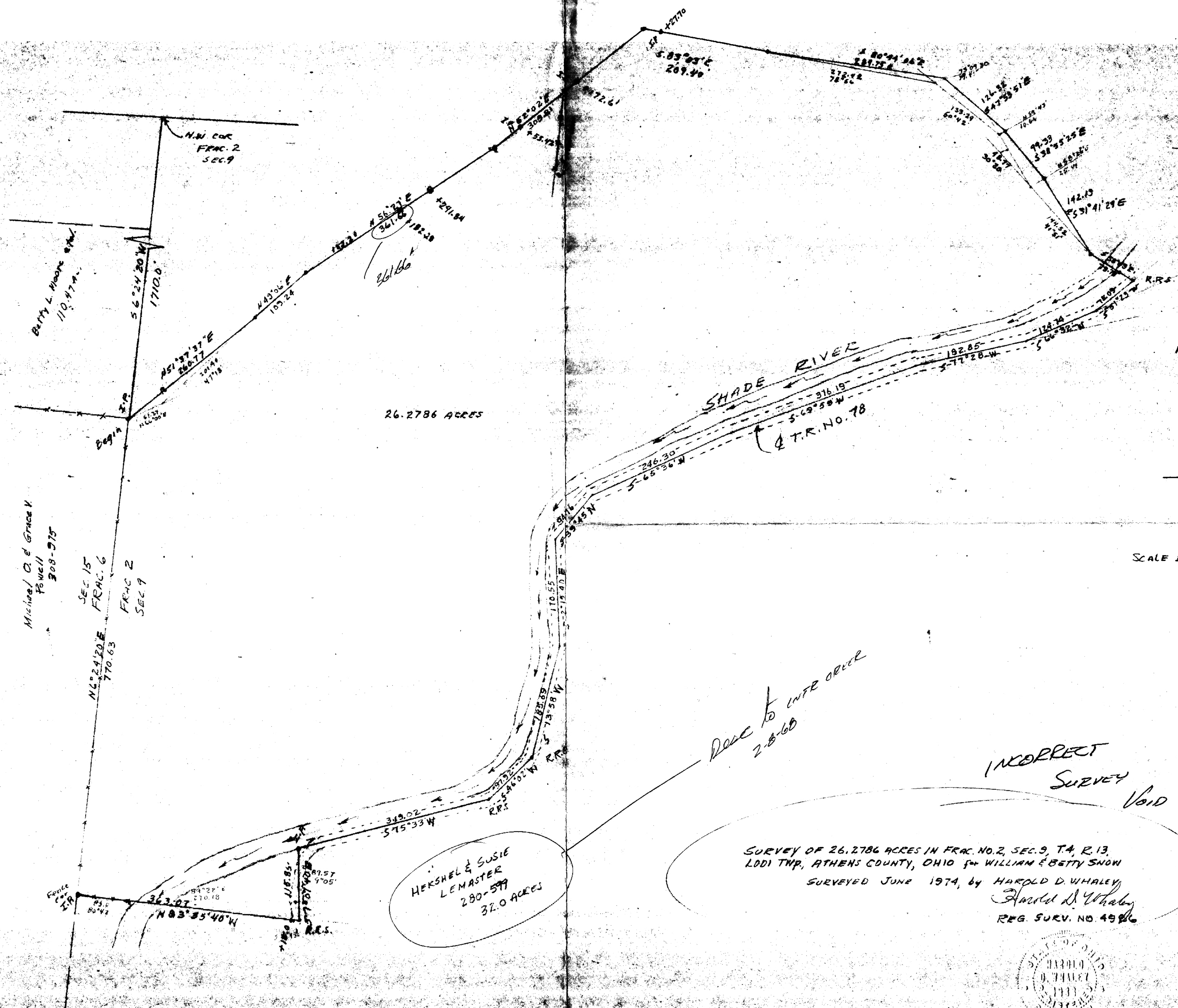
