Thence S03°40'57"W 142.97 feet to an iron pin set at the point of beginning of the tract herein described;

- 12.) Thence N45°05'22"E 78.88 feet to the point of beginning containing a total of 5.813 acres.

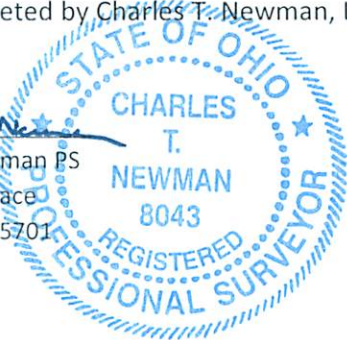

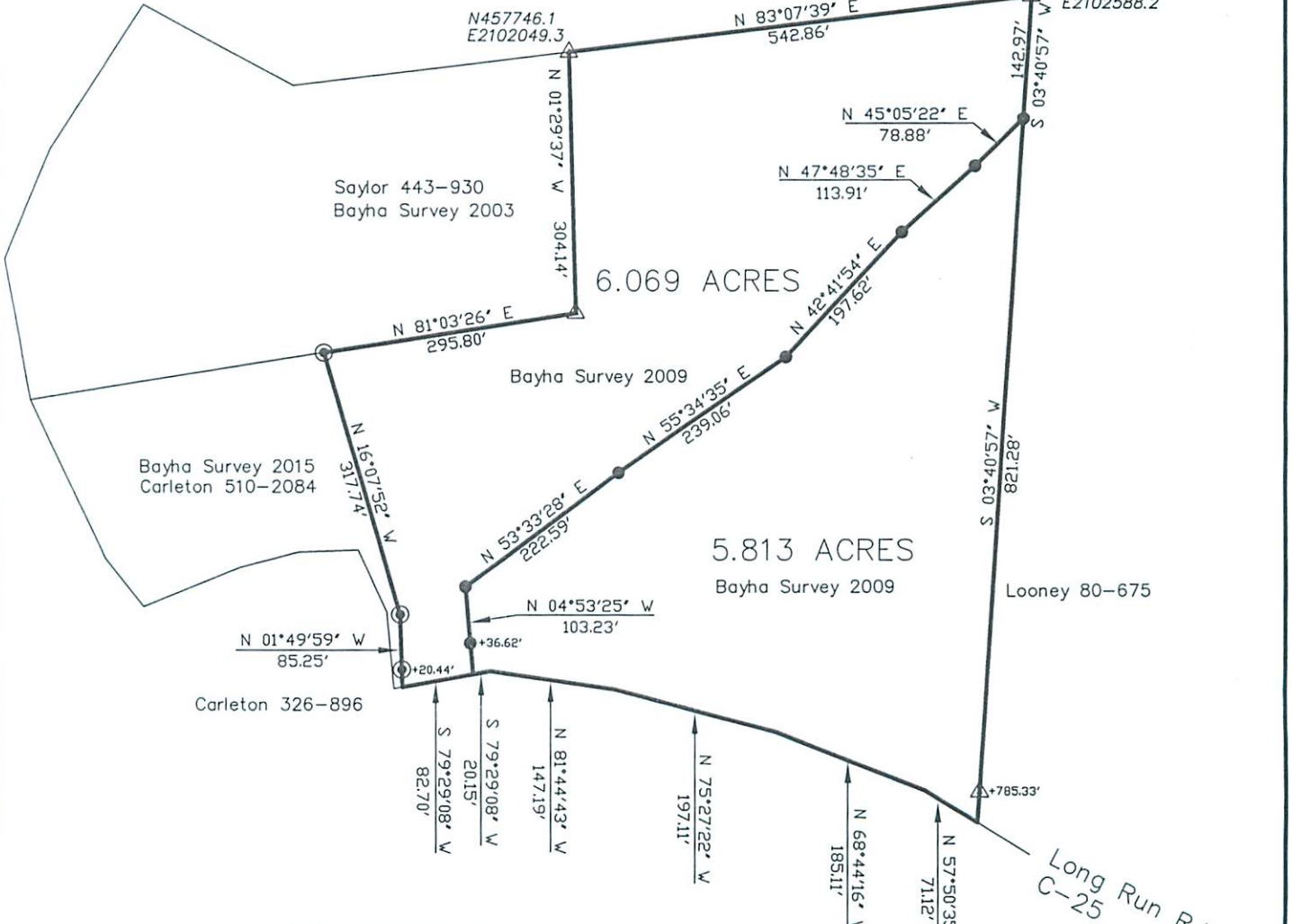
