Legal Description 0.464 Acres

Situated in the City of Nelsonville, Township of York, County of Athens, State of Ohio, and being a part of the Southwest Quarter of Section 24, Township 12N, Range 15W, and being more particularly described as follows;

Being a Survey of all of Parcel Five and Parcel Six conveyed to Pentajay Company, LLC, as recorded in O.R. Book 423, Page 2382, also including part of the Canal Lands and all of Lot 222-224 inclusive of E.J. Cable's Additon, as recorded in Plat Envelope 83C, as recorded in Plat Envelope 83C, in the Athens County Deed Records, also being all of Auditor's P.P.N. P03-01500001-00, P.P.N. P03-01500002-00, P.P.N. P03-01500003-00, & P.P.N. P03-01500004-00, and further described as follows;

Commencing at an iron pin set marking the Southwest corner of Lot 222 of E.J. Cable's Addition, as recorded in Plat Envelope 83C, also being the Southeast corner of Lot 221 conveyed to Beverly Stump, as recorded in O.R. Book 548, Page 886, being on the North Right of Way Line of The Hocking Valley Scenic Railroad, as recorded in O.R. Book 43, Page 649, and being the **PRINCIPLE PLACE OF BEGINNING** of the **0.464 Acre parcel** herein to be described;

Thence, N 03°24'29" E 119.71 feet with the West line of said Lot 222, the same being the East line of said Lot 221, and extending across part of the Canal Lands with the East line of said parcel conveyed to Stump (OR548,Pg886), to an iron pin set on the South Right of Way Line of Canal Street (U.S. Route 33)(70.55' Wide)(formerly Parkway Drive;

Thence, S 70°42'53" E 189.20 feet with the South Right of Way Line of said Canal Street, to a mag nail set at the intersection of the South Right of Way Line of Canal Street and the West Right of Way Line of Fulton Street (59.4' Wide);

Thence, S 03°24'29" W 105.23 feet with the West Right of Way Line of Fulton Street, the same being the East line of part of the Canal Lands and extending along the East line of Lot 224 of E.J. Cable's Addition, to a mag nail set on the North Right of Way Line of The Hocking Valley Scenic Railroad, as recorded in O.R. Book 43, Page 649;

Thence with the North Right of Way Line of The Hocking Valley Scenic Railroad with a curve to the left (radius= 2198.00 feet, Arc Length 185.82 feet, Delta Angle 04°50'35") with a chord bearing N 75°00'51" W 185.76 feet to the PRINCIPLE PLACE OF BEGINNING, and containing 0.464 Acres, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The bearings of the above description are based on the South Right of Way Line of Canal Street (U.S. Route 33)(70.55' Wide)(formerly Parkway Drive), as being N 70°42'53" W, and is an assumed Meridian used to denote angles only.

All iron pins set are 5/8" o.d. reinforcing bars 30" long with red caps labeled "S.A. ENGLAND #7452".
