PARCEL 1

Situate in Section 11, T6, R12, Rome Township, Athens County, Ohio. Being part of the R.B. and J.B. White parcels as described in Official Records Vol. 155, Pg. 28 of the Athens County Recorders Office and being described as follows:

Commencing at a stone found at the northeast corner of the southwest 1/4 of said Section 11; Thence S 03°33'36"W 2655.51 feet along the east line of the southwest 1/4 of Section 11 to a 48 inch diameter tree stump at the southeast corner of said southwest 1/4 (reference: iron pins set at 1355.68 feet and 2643.51 feet), said stump being the **POINT-OF-BEGINNING** for the parcel herein described;

Thence from this Point-of-Beginning N 87°12'31"W 690.93 feet along the south line of Section 11 to an iron pin set in Rome Township Road 461 (reference: iron pins set at 5.00 feet and 655.93 feet);

Thence along said Township Road 461 the following five courses:

- N 22°49'42" W 366.21 feet,
- N 25°15'04" W 155.59 feet,
- N 28°12'55" W 267.59 feet,
- N 26°08'47" W 606.65 feet,
- N 17°54'28" W 108.51 feet to an iron pin set;

Thence leaving said Township Road 461 N 86°00'23" W 35.21 feet to an iron pin set;

Thence N 03°59'37" E 231.00 feet to an iron pin set;

Thence S 86°00'23" E 774.84 feet to an iron pin set (reference: iron pin set at 35.00 feet);

Thence S 03°59'37" W 231.00 feet to an iron pin set;

Thence S 86°00'23" E 670.26 feet to an iron pin set on the east line of the southwest 1/4 of said Section 11;

Rom # 11

Thence S 03°33'36" W 1299.83 feet along the east line of the southwest 1/4 of Section 11 to the Point-of-Beginning (reference: iron pin set at 1287.83 feet).

Containing 35.663 acres as surveyed 07-05-1994 by Robert C. Canter, P.S. 7226.

Iron pins set are 5/8" x 30" rebar with plastic cap stamped "Canter P.S. 7226".

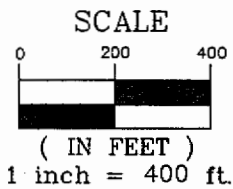
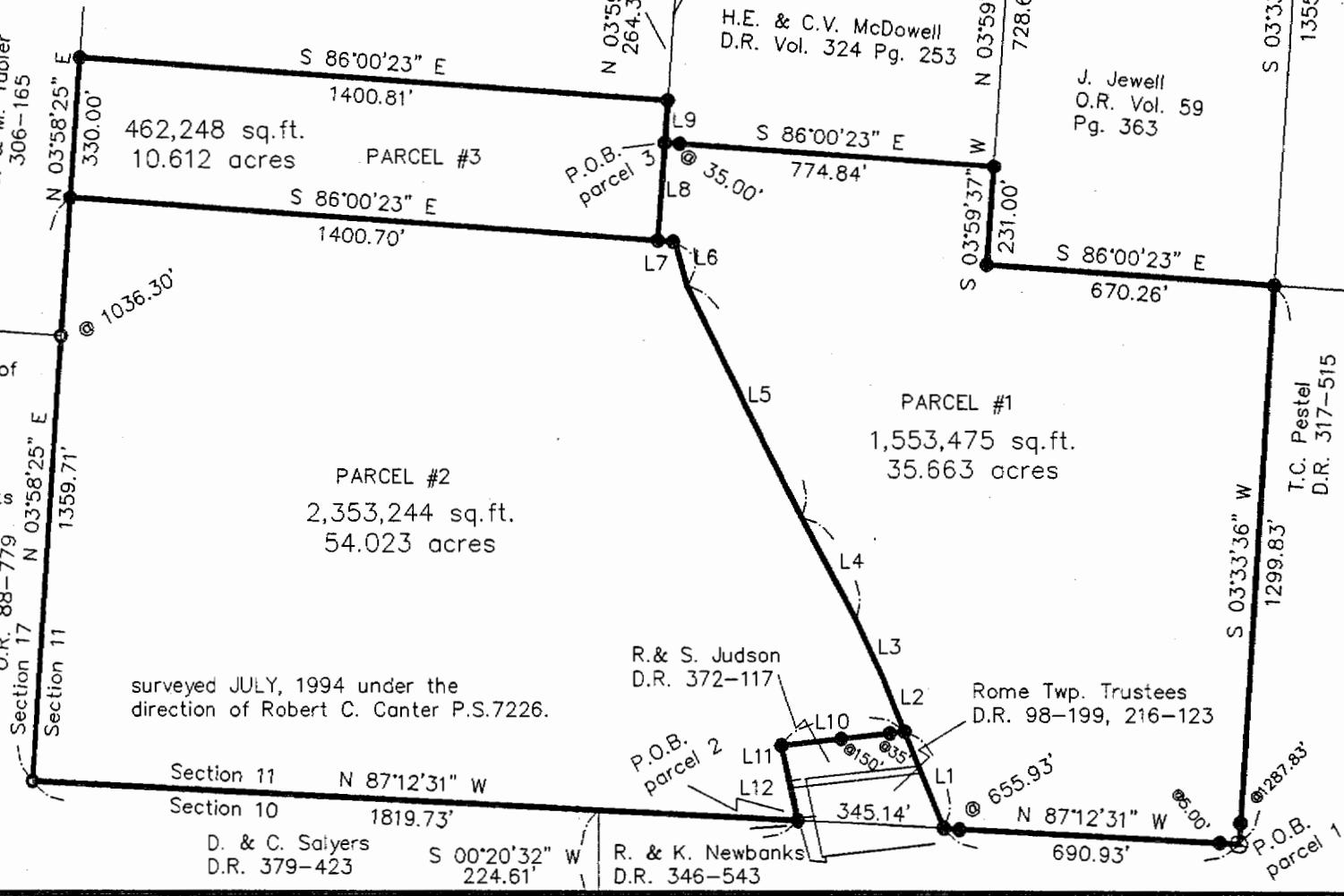
