Situate in Section 18, Town 6, Range 12, Rome Township, Athens County, State of Ohio and being more particularly described as follows:

Commencing at the Southeast corner of the Northeast one-quarter (1/4) of Section 18; thence S 88° 34' 17" W along the said South line of said Northeast one-quarter (1/4) of Section 18 (34.0 rods), 561.0 feet to an iron pipe set in the Grantor's most Easterly southeast corner, said iron pipe set also being the real point of beginning of the parcel herein described:
