Description of a parcel of land situate Ohio Company Purchase, Range 12, Town 6,
Section 23, Rome Township, Athens County, Ohio.
Being all of the Joseph McVey lands referenced in Official Record Book 324, Page 226, First Tract.

Commencing at a stone found at the northwest corner of Section 17;
Thence S04°27'29"W 1723.74 feet along the west line of Section 17 to an iron pin found,
and being the point of beginning of the tract herein described;

- 1.) Thence S04°27'29"W 985.24 feet along the west line of Section 17 to an iron pin set;
- 2.) Thence S04°27'29"W 1225.79 feet along the west line of Section 17 to an iron pin set;
- 3.) Thence N86°52'45"W 1443.76 feet along a common boundary to McVey 324/226, and to Orazen 295/963 to an iron pin set;
- 4.) Thence N03°46'33"E 2081.99 feet along a common boundary to McVey 324/226, and to Conley 321/1426 to an iron pin found;
- 5.) Thence N62°15'56"E 274.55 feet along a common boundary to McVey 324/226, and to Conley 321/1426 to a point in a creek;
- 6.) Thence S86°18'42"E 1235.93 feet along a common boundary to McVey 324/226, and to Conley 321/1426, and to Walker 508/2412 to the point of beginning, passing an iron pin found at 1031.09 feet, and containing a total of 73.792 acres;

Subject to all easements, rights-of-way, covenants and agreements of record.
Bearings are relative to an assumed north bearing of N04°27'29"E, and being the west line of Section 17.
Iron pins set are 5/8"x 30" rebar capped "NEWMAN 8043"

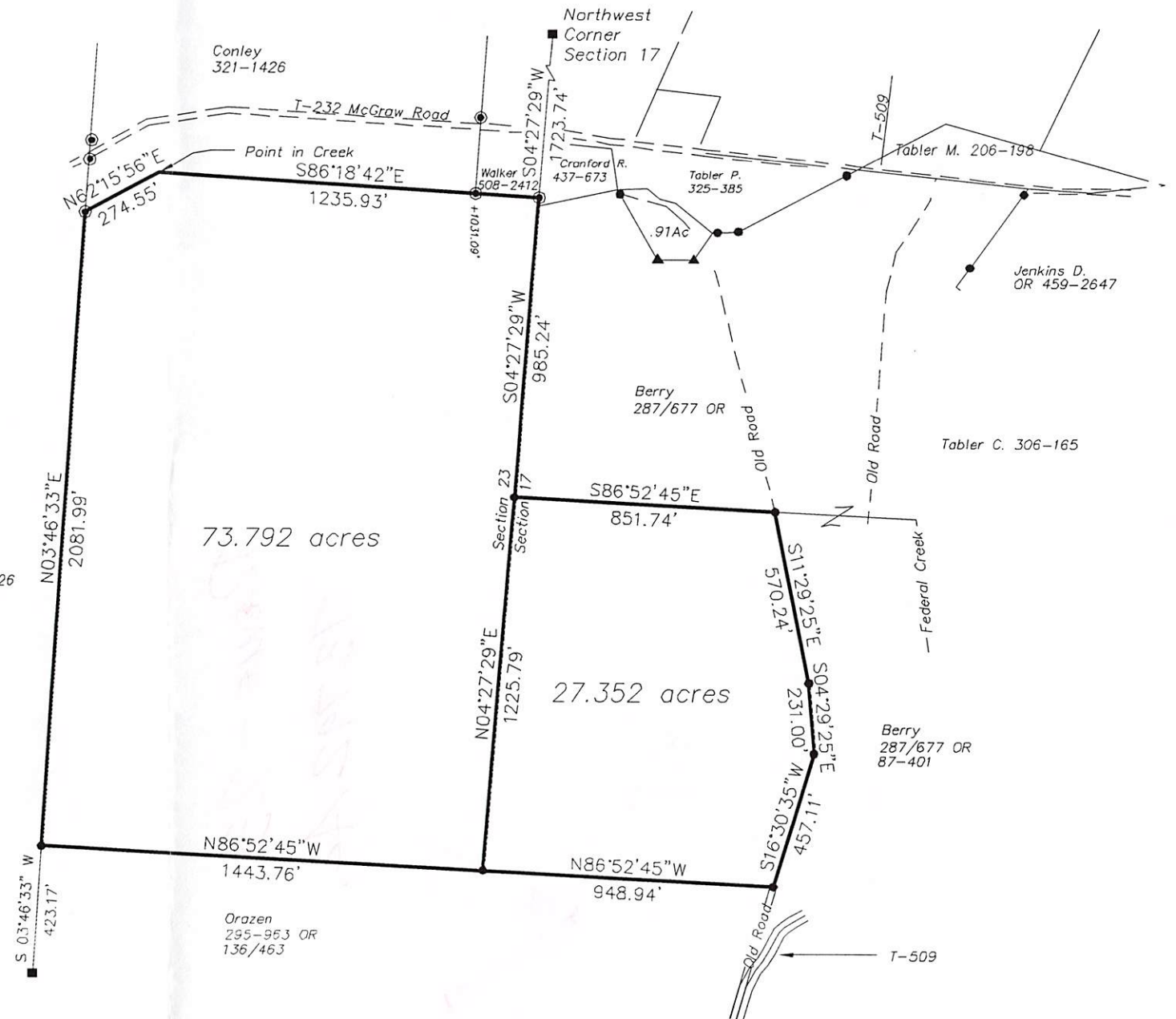
