Situated in Sections 25 and 26, Town 6, Range 12, Rome Township, Athens County, Ohio and described as follows:

Commencing at the northwest corner of Fraction 19 of Section 20 on the east line of Section 26; thence on an assumed bearing along an arbitrary line South 29 degrees 13 minutes 34 seconds West, a distance of 1985.44 feet to a set iron pin near an existing field fence, THE TRUE POINT OF BEGINNING; thence South 37 degrees 52 minutes 40 seconds East along the northerly projection of the west line of a 0.80 acre tract described in Volume 381 Page 151 of the Athens County Deed Records, passing a found iron pin at the northwest corner of said 0.80 acre tract at 228.86 feet, and a found iron pin at 324.43 feet, and the southwest corner of said 0.80 acre tract and centerline of State Route 329 at 350.43 feet, for a total distance of 492.98 feet to a point on the northerly line of a 106.05 acre tract described in Volume 113 Page 754 of the Athens County Official Deed Records; thence along the northerly line of said 106.05 acre tract along a non-tangential curve to the right a distance of 488.33 feet to a point, said curve has a radius of 5679.58 feet, a central angle of 4 degrees 55 minutes 35 seconds, and a chord which bears South 72 degrees 17 minutes 04 seconds West a distance of 488.18 feet; thence along a new property line North 17 degrees 29 minutes 52 seconds West, passing a set iron pin at 84.79 feet, for a total distance of 108.29 feet to a point in aforesaid State Route 329; thence along said State Route 329 South 72 degrees 41 minutes 52 seconds West, a distance of 147.83 feet to a point; thence leaving said State Route 329 and along a new property line the following three bearings and distances: 1) North 3 degrees 22 minutes 07 seconds West, passing a set iron pin at 33.52 feet, for a total distance of 97.90 feet to a set iron pin; thence 2) North 48 degrees 16 minutes 35 seconds West, a distance of 81.55 feet to a set iron pin; thence 3) North 4 degrees 47 minutes 24 seconds West, a distance of 241.20 feet to a set iron pin near an existing field fence; thence along said field fence the following five bearings and distances: 1) South 72 degrees 06 minutes 28 seconds East, a distance of 25.87 feet to a point; thence 2) North 87 degrees 59 minutes 27 seconds East, a distance of 65.25 feet to a point; thence 3) North 73 degrees 32 minutes 16 seconds East, a distance of 68.32 feet to a point; thence 4) North 76 degrees 09 minutes 53 seconds East, a distance of 210.27 feet to a point; thence 5) North 70 degrees 49 minutes 35 seconds East, a distance of 67.01 feet to the POINT OF BEGINNING and containing 5.572 acres, and being a part of a 71.66 acre tract described in Volume 207 Page 278 of the Athens County Official Deed Records. There are 1.8485 acres in Section 25 and 3.7235 acres in Section 26. Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. 6765. The above description was prepared under the supervision of Leonard F. 
