Situated in the northwest and the northeast quarter of Section 26, Town 6, Range 12, Rome Township, Athens County, Ohio and described as follows:

Commencing at the southwest corner of the northeast quarter of said Section 26, thence on an assumed bearing of North 21 degrees 00 minutes 47 seconds East, a distance of 582.99 feet to a point in the center of Rome Township Road 226, THE TRUE POINT OF BEGINNING; thence along the center of said Rome Township Road 226 the following five courses and distances 1. North 44 degrees 44 minutes 35 seconds West, a distance of 65.51 feet to a point; thence 2. North 49 degrees 21 minutes 03 seconds West, a distance of 85.38 feet to a point; thence 3. North 48 degrees 49 minutes 22 seconds West, a distance of 51.89 feet to a point; thence 4. North 45 degrees 48 minutes 42 seconds West, a distance of 56.15 feet to a point; thence 5. North 42 degrees 18 minutes 29 seconds West, a distance of 69.43 feet to a point; thence leaving the said Rome Township Road 226 and along the southerly property line of a 17.925 acre tract described in Volume 216 Page 372 of the Athens County Official Deed Records North 44 degrees 41 minutes 57 seconds East (passing a set iron pin* at 8.35 feet) for a total distance of 642.57 feet to a set iron pin* at the southeast corner of said 17.925 acre tract; thence South 58 degrees 10 minutes 36 seconds East, a distance of 476.28 feet to a set iron pin* at the northwest corner of a 22.942 acre tract described in Volume 283 Page 887 of the Athens County Official Deed Records; thence along the north property line of said 22.942 acre tract South 55 degrees 05 minutes 41 seconds West (passing a set iron pin at 741.43 feet) for a total distance of 755.66 feet to the POINT OF BEGINNING and containing 6.2288 acres, and being 0.019 acres out of a 60 acre (deed) tract described as Tract VII and 6.2098 acres out of a 192.27 acre (deed) tract described as Tract III in Volume 382 Page 489 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer P.L.S. 6765.


