Situated in Fraction 34, Section 28, Town 6, Range 12, Rome Township, Athens County, Ohio and described as.. follows:

Commencing at a found stone\* on the north line of Fraction 34 and the south line of Fraction 35 and located at the middle of said Fraction 34, said found stone is the northwest corner of an 8.0 acre tract described in Volume 186 Page 425 of the Athens County Official Deed Records; thence along the north line of Fraction 34 and the south line of Fraction 35 and the north line of said 8.0 acre tract on an assumed bearing North 89 degrees 45 minutes 34 seconds East, a distance of 792.00 feet to a set iron pin at the northeast corner of said 8.0 acre tract, THE TRUE POINT OF BEGINNING; thence continuing along the north line of said fraction 34 and the south line of Fraction 35 and the south line of the lands described in Volume 186 Page 425 of the Athens County Official Deed Records North 89 degrees 45 minutes 34 seconds East, a distance of 190.01 feet to a set iron pin; thence leaving the north line of Fraction 34 and the south line of Fraction 35 and along an arbitrary line South 00 degrees 00 minutes 00 seconds East, passing a set iron pin at 452.24 feet, for a total distance of 467.24 feet to a set railroad spike in Rome Township Road 231; thence along Rome Township Road 231 South 71 degrees 48 minutes 42 seconds West, a distance of 200.00 feet to a found railroad spike at the northeast corner of a 27.41 nore tract described in Volume 369 Page 777 of the Athens County Deed Records at the southeast corner of a 4.0 acre tract described in Volume 97 Page 250 of the Athens County Official Deed Records; thence leaving Rome Township Road 231 and along the east line of said 4.0 acre and the east line of aforesaid 8.0 acre tract North 00 degrees 00 minutes 00 seconds East, passing a set iron pin at 15.00 feet, for a total distance of 528.87 feet to the POINT OF BEGINNING and containing 2.172 acres, and being a part of Tract Two of the tracts of land described in Volume 336 Page 129 of the Athens County Deed Records. \*denotes calculated location based on a previous survey.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.
