Situated in Fraction 3, Section 9, Town 6, Range 12, Rome Township, Athens County, Ohio and described as follows:

Commencing at the southeast corner of Section 9; thence on an assumed bearing North 00 degrees 00 minutes 00 seconds East, a distance of 165.00 feet to a point; thence North 90 degrees 00 minutes 00 seconds East, a distance of 2179.24 feet to a point at the southwest corner of a 1.01 acre tract described in Volume 310 Page 459 of the Athens County Deed Records; thence North 00 degrees 00 minutes 00 seconds East along the west line of said 1.01 acre tract, passing a found iron pin at 283.95 feet, for a total distance of 318.95 feet to a point at the northwest corner of said 1.01 acre tract in State Route 144; thence along State Route 144 the following two bearings and distances: 1) North 72 degrees 27 minutes 42 seconds West, a distance of 261.66 feet to a point; thence 2) North 80 degrees 12 minutes 10 seconds West, a distance of 549.29 feet to a point, THE TRUE POINT OF BEGINNING; thence leaving said road along an arbitrary line the following five bearings and distances: 1) South 11 degrees 00 minutes 00 seconds West, passing a set iron pin at 32.57 feet, for a total distance of 312.75 feet to a set iron pin; thence 2) South 13 degrees 31 minutes 33 seconds West, a distance of 232.48 feet to a set iron pin; thence 3) South 86 degrees 20 minutes 04 seconds West, a distance of 487.07 feet to a set iron pin; thence 4) South 60 degrees 10 minutes 22 seconds West, a distance of 982.70 feet to a set iron pin; thence 5) North 3 degrees 01 minute 28 seconds West, passing a set iron pin at 585.71 feet, for a total distance of 605.00 feet to a point in aforesaid State Route 144; thence along said road the following two bearings and distances: 1) North 70 degrees 11 minutes 42 seconds East, a distance of 50.00 feet to a point; thence 2) North 75 degrees 35 minutes 09 seconds East, a distance of 174.13 feet to a point at the intersection of said State Route 144 with an existing culvert at the southeast corner of a 3.37 acre tract described in Volume 135 Page 169 of the Athens County Official Deed Records; thence along the east line of said 3.37 acre tract North 0 degrees 54 minutes 51 seconds West, a distance of 234.47 feet to a point in the center of the Hocking River; thence along the center of said Hocking River the following two bearings and distances: 1) North 62 degrees 55 minutes 16 seconds East, a distance of 351.47 feet to a point; thence 2) North 47 degrees 19 minutes 45 seconds East, a distance of 682.35 feet to a point in Rome Township Road 189; thence along said Rome Township Road 189 South 16 degrees 31 minutes 03 seconds East, a distance of 305.93 feet to a point at the intersection of said Rome Township Road 189 with aforesaid State Route 144; thence along said State Route 144 the following four bearings and distances: 1) North 85 degrees 41 minutes 14 seconds East, a distance of 35.27 feet to a point; thence 2) South 68 degrees 59 minutes 10 seconds East, a distance of 69.80 feet to a point; thence 3) South 59 degrees 15 minutes 50 seconds East, a distance of 222.82 feet to a point; thence 4) South 63 degrees 51 minutes 05 seconds East, a distance of 88.16 feet to the POINT OF BEGINNING and containing 24.879 acres, and being a part of a 168.63 acre tract described in Volume 301 Page 131 of the Athens County Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.
