

64.352 Acres

Description of a tract of land situate Ohio Company Purchase, Town 6, Range 12, Fraction 17 and Fraction 23, Auditor's Section 22, Rome Township, Athens County, Ohio. Being deeded to Tracy Skellett and Gary Norris, Official Record Book 462, pages 289-290, and being a part of the First Tract and Second Tract .

Commencing at an iron pin found at the southeast corner of said Fraction 17; Thence S89°24'14"W 1764.72 feet along the south boundary of Fraction 17 to an iron pin set in a small stream, (passing a stone found at 977.67 feet) and being the point of beginning of the tract herein described;

There are 16.602 acres are in Fraction 23 and 47.75 acres are in Fraction 17.

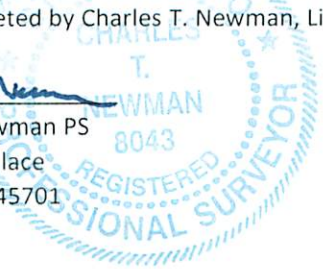

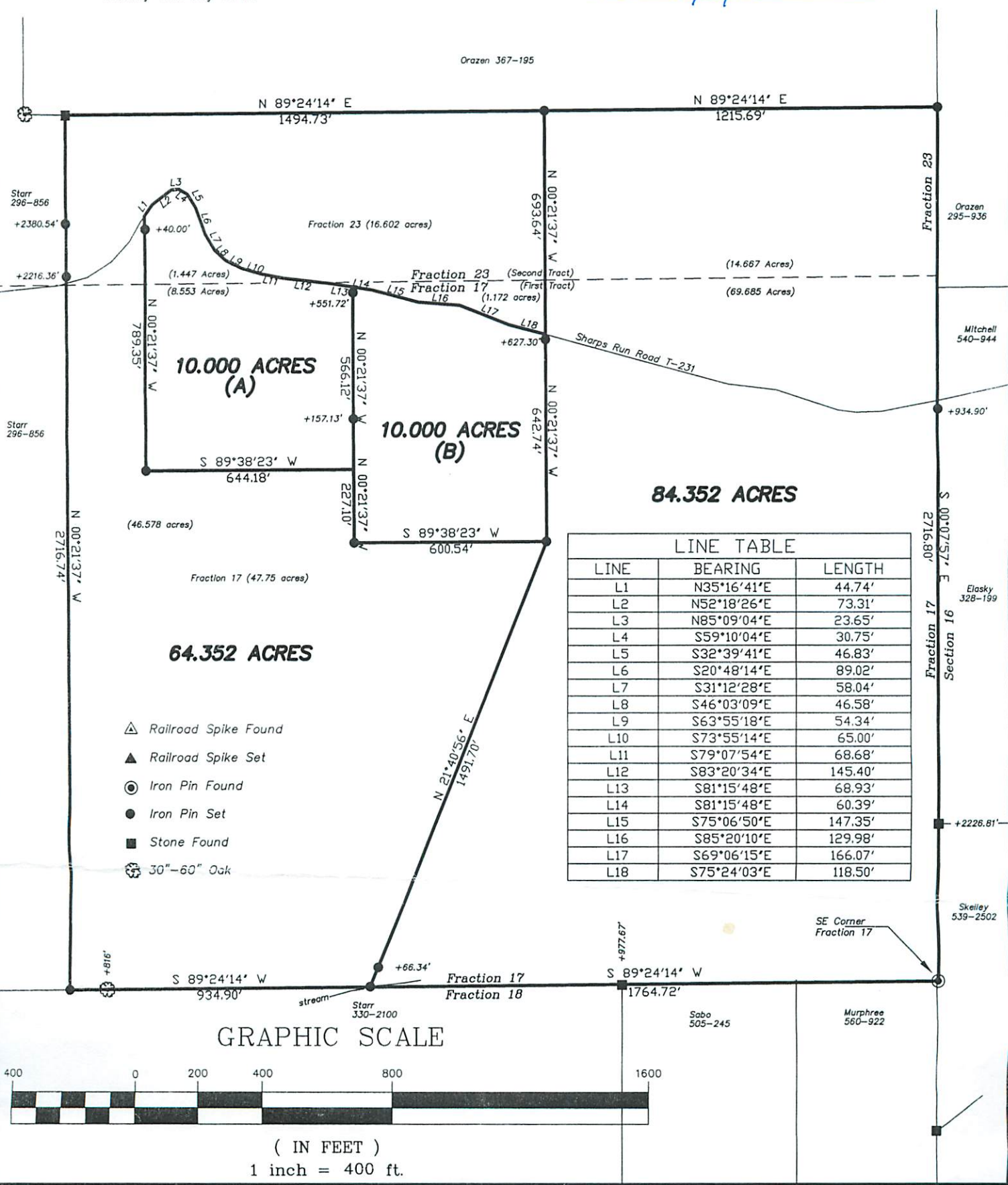
