## DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Trimble, T-11, R-14, being a part of Charles S. Vernon and Annelie Arnold, OR. 108 Pg. 412, being part of the Northwest Quarter of the Northwest Quarter of Section 2, and more particularly described as follows:

Beginning at a stone found at the Southwest Corner of the Northwest Quarter of the Northwest Quarter of Section 2; thence South 87 Degrees 28 Minutes 29 Seconds East 840.32 feet to an iron pin found and the place of beginning; thence North 33 Degrees 29 Minutes 03 Seconds West 407.93 feet to an iron pin found; thence North 51 Degrees 55 Minutes 52 Seconds West 150.00 feet to an iron pin found; thence North 34 Degrees 11 Minutes 17 Seconds East 73.45 feet to an iron pin set; thence South 30 Degrees 47 Minutes 59 Seconds East 84.52 feet to an iron pin set in the center of a meandering creek; thence with said creek South 45 Degrees 08 Minutes 04 Seconds East 180.29 feet to a point; thence continuing with said creek South 17 Degrees 43 Minutes 14 Seconds East 114.58 feet to a point; thence continuing with said creek South 42 Degrees 24 Minutes 16 Seconds East 97.66 feet to an iron pin set in the center of said creek; thence leaving said creek South 87 Degrees 28 Minutes 29 Seconds East 35.00 feet to an iron pin found; thence South 02 Degrees 31 Minutes 31 Seconds West 111.00 feet to the place of beginning containing 0.51 acres, more or less, subject to all legal highways and easements.

Bearings are based on the South line of the Northwest Quarter of Northwest Quarter of Section 2.


