

SITUATED IN THE STATE OF OHIO, COUNTY OF ATHENS, TOWNSHIP OF TRIMBLE, SECTION #21, AND BEING A PART OF FRACTION #30 IN TOWNSHIP-11, RANGE-14 OF THE OHIO COMPANY'S PURCHASE, AND BEING ALL OF THE PARCEL CONVEYED TO BARL L. AND FONDA GILKEY AS FOUND IN OFFICIAL RECORD 122 PAGE 800, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND MARKING THE NORTHWEST CORNER OF FRACTION #30, THENCE S $03^{\circ}\,44^{\circ}00^{\circ}$ W 294.67 FEET TO A POINT, THENCE WITH THE SOUTH LINE OF FRACTION #30 S $86^{o}16'00''$ E 2718.03 FEET TO AN IRON PIN SET AND BEING THE SOUTHEAST CORNER AND THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED:

THENCE, WITH THE EAST LINE OF A PARCEL CONVEYED TO HELEN R. BURK AS FOUND IN DEED VOLUME 342 PAGE 593, N 12°31'15" B 290.07 FEET TO AN IRON PIN SET IN MUD FORK CREEK, SAID POINT BEING THE NORTHWEST CORNER OF THE PARCEL HEREIN TO BE DESCRIBED:

THENCE, WITH MUD FORK CREEK THE FOLLOWING THREE (3) COURSES AND DISTANCES:
