SITUATED IN THE STATE OF OHIO, COUNTY OF ATHENS, TOWNSHIP OF TRIMBLE, BEING A PART OF SOUTHWEST QUARTER SECTION #25, T-11, R-14, OF THE OHIO COMPANY'S PURCHASE AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING, FOR REFERENCE, AT AN IRON PIN FOUND MARKING THE SOUTHWEST CORNER OF SECTION #25, THENCE WITH THE SOUTH LINE OF SECTION 25 N 77 49 15" E 1257.30 FEET TO A IRON PIN SET, AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED:

THENCE, N 11°35'23" W 176.48 FEET WITH THE EAST LINE OF A PARCEL CONVEYED TO THE UNITED STATES OF AMERICA AS FOUND IN OFFICIAL RECORD 95 PAGE 852 IN THE ATHENS COUNTY RECORDER'S OFFICE, TO A POINT IN THE CENTERLINE OF STATE ROUTE #685 PASSING A REFERENCE IRON PIN SET AT 141.48 FEET, SAID POINT BEING THE NORTHWEST CORNER OF THE PARCEL HEREIN DESCRIBED;

THENCE, WITH THE CENTERLINE OF STATE ROUTE #685 SAID CENTERLINE BEING THE SOUTHERLY PROPERTY LINE OF A PARCEL CONVEYED TO ROBERT W. ERDY AS FOUND IN OFFICIAL RECORD 145 PAGE 508 IN THE ATHENS COUNTY RECORDERS OFFICE;


