Description of Parcel No. 7 (60.105 Acres)

The following described parcel is a new split out of a 176.08 acres tract as conveyed to Agri Soils, Ltd. by Official Records Volume 560, Page 874 of the Athens County Recorder's Office.

thence, with a the south line of Section 7, South 86°47'06" East a distance of 1,119.43 feet to a point in or near the center of Sunday Creek, being <u>THE TRUE POINT OF BEGINNING</u> for this description;

thence, with said Robson 0.9125 acre tract, the following 2 courses:

- 1. North 86°28'47" West a distance of 224.65 feet to a point;
- 2. thence South 02°55'57" East a distance of 100.00 feet to a 1" pipe found in the north line of a 4.93 acres tract as conveyed to Colton D. Joyce by Official Records Volume 503, Page 1637 of the Athens County Recorder's Office, passing through a 1" iron pipe found at a distance of plus 0.38 feet;

thence, with said Joyce property, the following 2 courses:

- 1. North 86°28'47" West a distance of 300.73 feet to a 5/8" iron pin found uncapped;
