Beginning at a point at the Northeast Corner of Lot 11 of the Original Plat of Trimble Plat Book 2 Pg. 40; thence along the North Line of Mill Street South 83 Degrees 48 Minutes 49 Seconds East 33.90 feet to an iron pin found; thence South 07 Degrees 03 Minutes 49 Seconds East 107.84 feet to an iron pin found; thence North 66 Degrees 59 Minutes 00 Seconds East 248.16 feet to an iron pin found; thence South 12 Degrees 00 Minutes 34 Seconds East 386.68 feet to an iron pin found and the place of beginning; thence North 87 Degrees 26 Minutes 09 Seconds West 110.46 feet to an iron pin found, passing an iron pin set at 98.83 feet; thence North 63 Degrees 18 Minutes 16 Seconds East 13.38 feet to an iron pin found; thence South 83 Degrees 38 Minutes 49 Seconds East 99.00 feet to the place of begining, containing 0.01 acres, more or less, subject to all legal highways and easements.




