2. Along a curve to the left 178.19 feet, having a radius of 3979.46 feet, a central angle of 02°33'56" and a chord bearing of S50°41'54"W 178.18 feet to railroad spike set on the west line of said Carl Gillilan and Frances Gillilan at centerline station 1+69.14, 0.00 feet right;
