Situated in the State of Ohio, Athens County, Troy Township, Township 5 North, Range 11 West, Section 6, being a part of a 41.04 Acre Parcel conveyed to Robert Wayne Mulligan as recorded in Official Record 61 on Page 398, bounded and described as follows.


Beginning for reference at a iron pin at the southeast corner of the northeast quarter of Section 6, THENCE along the Athens and Washington County Line, N 07 16' 08" E a distance of 575.37 feet to a 5/8" capped rebar set, said rebar being the True Point of Beginning for the parcel herein described. THENCE N 87 07' 51" W a distance of 159.93 feet to a 5/8" capped rebar set; THENCE S 41 09' 26" W a distance of 163.97 feet to a 5/8" capped rebar set; THENCE S 66 11' 33" W a distance of 129.94 feet to a 5/8" capped rebar set; THENCE N 25 14' 41" W a distance of 389.57 feet to a point in the center of Troy Township Road 179, Sawyer Road, passing a 5/8" capped rebar set at 372.95 feet; THENCE along the center of Sawyer Road the following ten (10) courses, N 53 22' 39" E a distance of 82.43 feet to a point; THENCE N 57 25' 51" E a distance of 98.03 feet to a point; THENCE N 59 41' 21" E a distance of 91.05 feet to a point; THENCE N 61 58' 20" E a distance of 66.79 feet to a point; THENCE N 66 21' 04" E a distance of 45.46 feet to a point; THENCE N 74 40' 32" E a distance of 43.69 feet to a point; THENCE N 81 38' 14" E a distance of 198.14 feet to a point; THENCE N 71 05' 39" E a distance of 24.06 feet to a point; THENCE N 55 28' 51" E a distance of 20.67 feet to a point; THENCE N 34 28' 48" E a distance of 6.70 feet to a point on the Athens/Washington County line; THENCE leaving said Sawyer Road, S 07 16' 08" W a distance of 451.00 feet, to the Point of Beginning, containing 5.0197 Acres. 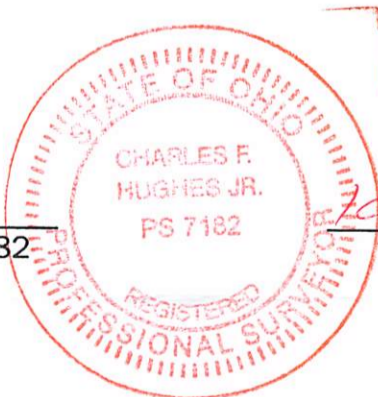
Subject to all legal highways, right of ways, easements, restrictions and reservations of record.

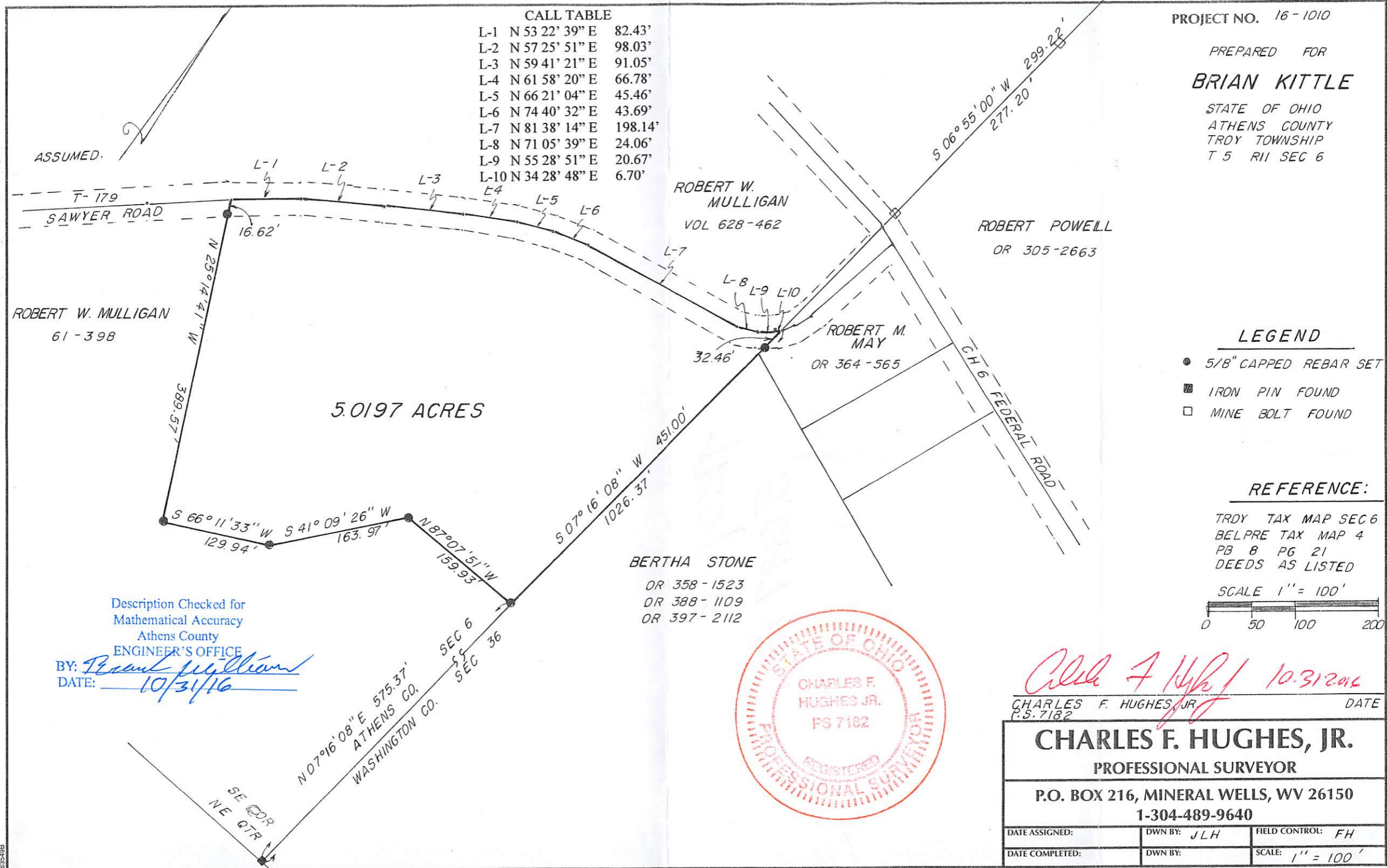

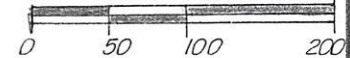
