


Description of 82.354 Acres

Description of a parcel of land situate the Ohio Company Purchase Town 5, Range 11, Fraction 24, Auditor's Section 9, Troy Township, Athens County, Ohio. Being lands deeded to Joseph Krupinski, Official Record Book 553, pages 2166-2169, and being more fully described as follows:

Beginning at a MAG Nail set over an iron pin found at the southwest corner of said Fraction 12, and being in the center of Township Road 172, Cincinnati Ridge;

- 1.) Thence N89°32'31"E 872.05 feet along a common boundary to George 131-457, Schaffer 408-2632, and Krupinski 553-2166 to a point in the center of Township Road 172;
- 2.) Thence S00°19'57"W 212.02 feet along a common boundary to Tholin 552-2269 and Krupinski 553-2166 to an iron pin found, passing an iron pin found at 15.00 feet;
- 3.) Thence S01°44'17"W 414.98 feet along a common boundary to Tholin 531-2487 and Krupinski 553-2166 to an iron pin found;
- 4.) Thence S88°41'59"E 445.72 feet along said common boundary to an iron pin found;
- 5.) Thence N87°35'23"E 38.68 feet along a common boundary to Tholin 522-2269 and Krupinski 553-2166 to an iron pin set;
- 6.) Thence S00°02'14"W 2276.39 feet along a common boundary to Rader 349-767 and Krupinski 553-2166 to an iron pin found;
- 7.) Thence N88°48'27"W 1343.15 feet along a common boundary to Creamer 509-248 and Krupinski 553-2166 to an iron pin found;
- 8.) Thence N00°02'14"E 2876.76 feet, passing an iron pin set at 2847.94 feet and being along a common boundary to Simmons 311-14 and Krupinski 553-2166 to the point of beginning containing a total of 82.354 acres.

Plat of Survey is attached herewith and made a part thereof.  
Subject to all easements, rights-of-way, covenants and agreements of record.  
Iron pins set are 30 inches length number 5 rebar capped "NEWMAN PS-8043"  
Basis of bearings the south line of Fraction 24, an assumed bearing.

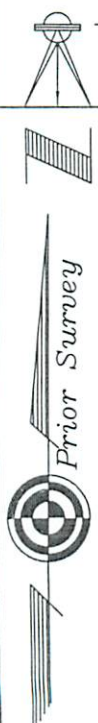

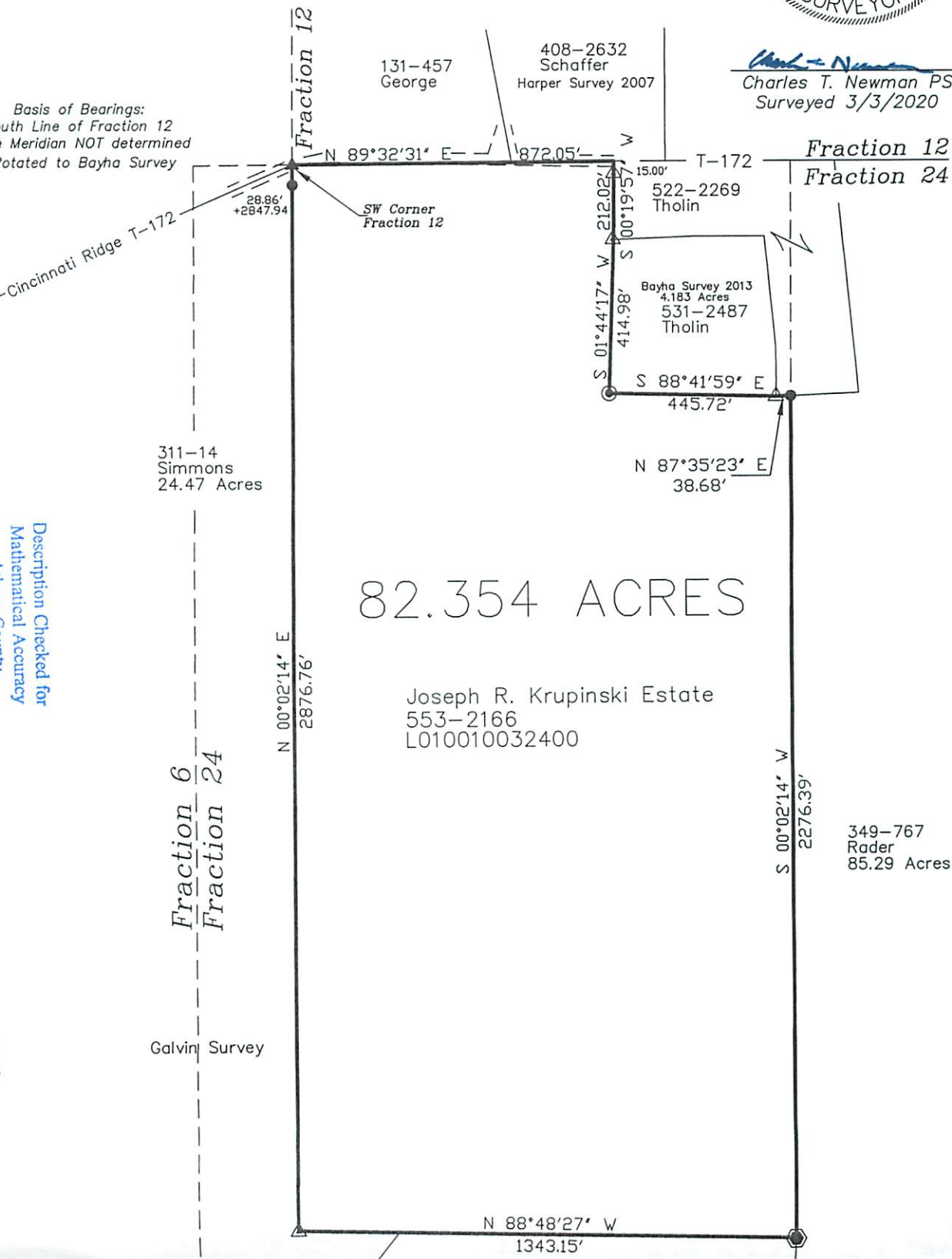
