DESCRIPTION OF A 17.05 ACRE TRACT

Situated in Fraction 23, T.11, R.15, Waterloo Township, Athens County, Ohio and being more particularly described as follows:

Beginning at an iron pin set in Township road 264, said pin bears South 87 Degrees East, 22.6 chains (deed) from the North-west corner of Fraction 23;

Thence, along Grantor's North-line, South 87 Degrees 00 Minutes East, 197.89 feet to a point in Township Road 445; thence, leaving said road, South 17 Degrees 29 Minutes 55 Seconds West, 1729.38 feet to a railroad spike set in State Route 56, passing iron pins set at 20.09 feet and 1084.76 feet; thence, with State Route 56, South 88 Degrees 18 Minutes 19 Seconds West, 133.27 feet to a point; thence, South 75 Degrees 51 Minutes 17 Seconds West, 96.46 feet to a railroad spike at the South-east corner of a 7.46 acre tract; thence, along the East-line of said tract, North 01 Degree 31 Minutes 52 Seconds West, 983.25 feet to an iron pin at the North-east corner of said tract, thence, North 83 Degrees 22 Minutes 48 Seconds West, 310.22 feet to a point in State Route 56, passing an iron pin at 266.52 feet; thence, with said road, North 00 Degrees 18 Minutes 42 Seconds West, 34.82 feet to a railroad spike set; thence, leaving said road, North 67 Degrees 30 Minutes East, 401.79 feet to an iron pin at the South-east corner of a 1.0 acre tract (Vol. 246, Page 400) thence, North 01 Degrees 18 Minutes 57 Seconds West, 41.10 feet to an electric pole; thence, North 15 Degrees 56 Minutes 16 Seconds West, 105.80 feet to a railroad spike set in Township Road 264; thence, with said road, North 79 Degrees 00 Minutes East, 32.29 feet to a point; thence, North 70 Degrees 00 Minutes East, 316.80 feet to a point; thence, North 43 Degrees 45 Minutes East, 303.22 feet to the point of beginning and containing 17.05 acres.

DESCRIPTION OF A 0.08 ACRE TRACT

Situated in Fraction 23, T. 11, R. 15, Waterloo Township, Athens County, Ohio and being more particularly described as follows:

Commencing at an iron pin set in Township road 264, said pin bears South 87 Degrees East, 22.6 chains (deed) from the North-west corner of Fraction 23; thence, along Township Road 264, South 43 Degrees 45 Minutes West, 308.22 feet to a point; thence, South 70 Degrees 00 Minutes West, 316.80 feet to a rail road spike, said spike being the point of beginning for the tract of land herein described:

Thence, South 15 Degrees 56 Minutes 16 Seconds East, 105.80 feet to an electric pole; thence, South 01 Degree 18 Minutes 57 Seconds East, 41.10 feet to an iron pin at the South-east corner of a 1.0 acre tract (Vol. 246, Page 400); thence, with the East-line of said 1.0 acre tract, North 27 Degrees 00 Minutes West, 151.80 feet to a railroad spike in Township Road 264; thence, with said road, North 79 Degrees 00 Minutes E, 39.65 feet to the point of beginning and containing 0.08 acres.

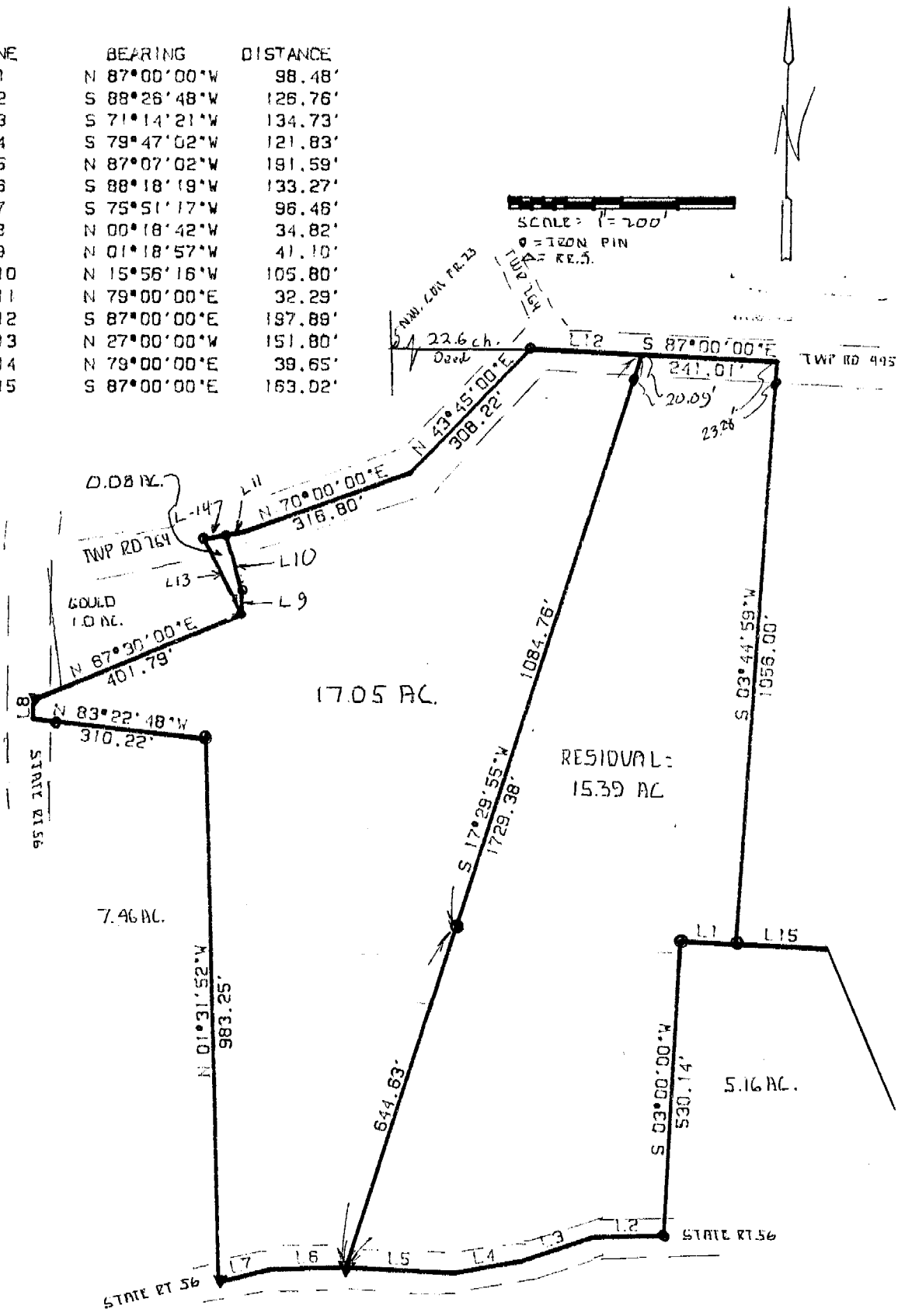
