Commencing for reference at a stone found at the Northeast corner of Section 3, Starr Township, Hocking County which is the West line of Athens County; thence with the Athens - Hocking County line South 0 degrees 10 minutes 01 second West a distance of 1153.94 feet to a 5/8" iron pin previously set on the west line of Section 33, York Township, Athens County; thence leaving the West line of Section 33 North 88 degrees 44 minutes 17 seconds East a distance 1381.76 feet to a 5/8" iron pin set and being the point of **Beginning** of the tract of land to be described;

thence continuing North 88 degrees 44 minutes 17 seconds East a distance of 55.55 feet to a 5/8" iron pin set;

thence South 23 degrees 10 minutes 49 seconds East a distance of 721.87 feet to a 5/8" iron pin previously set in the center of Township Road 275 and passing a 5/8" iron pin set at a distance of 706.87 feet;

thence with the center of Township Road 275 the following five bearings and distances:

- 1) South 45 degrees 10 minutes 47 seconds West a distance of 111.19 feet to a 5/8" iron pin previously set;
- 2) South 45 degrees 05 minutes 17 seconds West a distance of 140.21 feet to a 5/8" iron pin previously set;
- 3) South 53 degrees 10 minutes 38 seconds West a distance of 68.85 feet to a 5/8" iron pin previously set;
- 4) South 72 degrees 04 minutes 31 seconds West a distance of 72.84 feet to a 5/8" iron pin previously set;
- 5) South 82 degrees 48 minutes 14 seconds West a distance of 116.64 feet to a 5/8" iron pin previously set;

thence leaving the center of Township Road 275 North 4 degrees 53 minutes 41 second East a distance of 921.39 feet to the point of beginning, passing a 5/8" iron pin set at a distance of 15.00 feet, containing 5.015 acres more or less and subject to the public easement of Township Road 275 and any other public or private easements of record.


