

SURVEY DESCRIPTION OF A 5.007 ACRE TRACT ON TOWNSHIP ROAD 276

Situated in York Township, Athens County, Ohio; being part of Fractional Lots 31 and 32 of Section 33, Township 12, Range 15; and being more particularly described as follows:

Commencing for reference at a wood post found at a point taken to be the Southwest corner of Section 33; thence with the South line of Section 33 South 89 degrees 12 minutes 09 seconds East a distance of 3782.27 feet to a 5/8" iron pin previously set; thence leaving the South line of Section 33 North 0 degrees 12 minutes 09 seconds West a distance of 1043.09 feet to a 5/8" iron pin previously set; thence North 44 degrees 56 minutes 10 seconds West a distance of 1825.28 feet to a 5/8" iron pin set and being the point of **Beginning** of the tract of land to be described;

thence continuing North 44 degrees 56 minutes 10 seconds West a distance of 142.63 feet to a 5/8" iron pin set;

thence North 35 degrees 51 minutes 43 seconds East a distance of 1235.28 feet to a PK nail set in the surface of Township Road 276 and passing 5/8" iron pins set at distances of 978.35 feet and 1220.28 feet;

thence with the surface of Township Road 276 the following two bearings and distances:

1) South 54 degrees 08 minutes 17 seconds East a distance of 40.67 feet to a 5/8" iron pin previously set;

2) South 50 degrees 52 minutes 25 seconds East a distance of 168.85 feet to a PK nail set;

thence leaving the surface of Township Road 276 South 39 degrees 00 minutes 00 seconds West a distance of 1250.35 feet to the point of beginning, passing 5/8" iron pins set at distances of 18.00 feet and 259.99 feet, containing 5.007 acres more or less, and subject to the public easement of Township Road 276 and any other public or private easements of record.

The above 5.007 acre survey is intended to describe part of the tracts as deeded to Larry P. Gerstner, deed references Volume OR256, Page 679, and Volume OR257, Page 753, both of the Athens County Recorder's Office. This survey was based upon information obtained from tax maps, deed descriptions, previous surveys, existing monumentation, existing fence lines, and existing public roads. The reference bearing for this survey is the West line of the South half of Section 33 as North 0 degrees 00 minutes 00 seconds West. Bearings are based upon an assumed meridian and are to denote angles only. All iron pins set by this survey or previously set are 5/8" by 30" (15" in roadway) and are capped by a 1-1/4" plastic identification cap stamped LPG-6344. The above described property was surveyed by Larry P. Gerstner, Ohio Registered Surveyor No. 6344, on November 25, 1997.

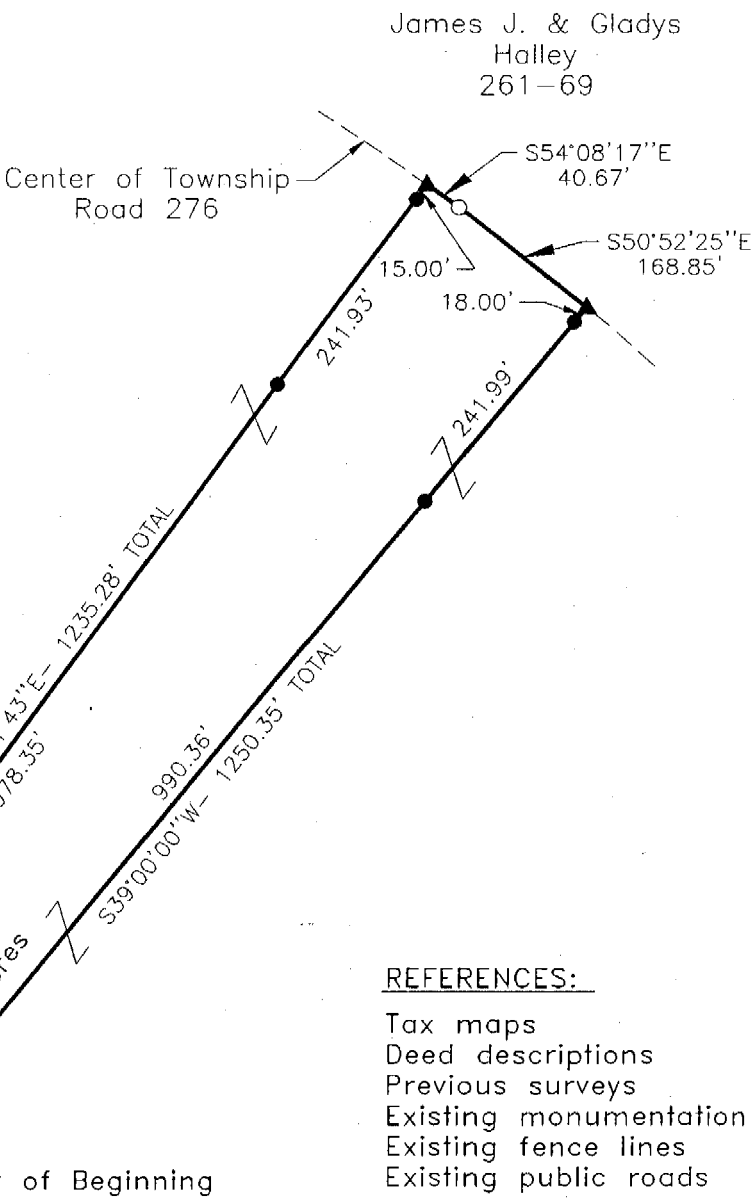

PLAT OF A 5.007 ACRE TRACT ON TOWNSHIP ROAD 276

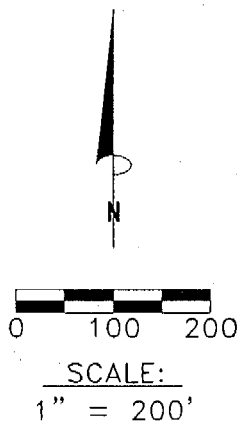
Situated in York Township, Athens County, Ohio; being part of Fractional Lots 31 and 32 of Section 33, Township 12, Range 15.

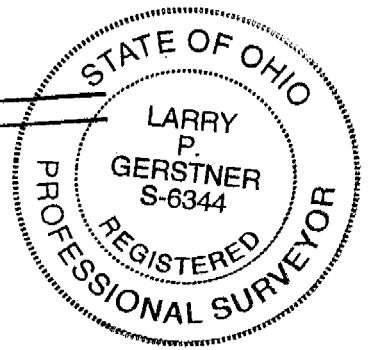
- 5/8"x 30" (15" in roadway) iron pin with 1-1/4" plastic ID cap stamped LPG-6344 previously set

- ▲ PK nail set



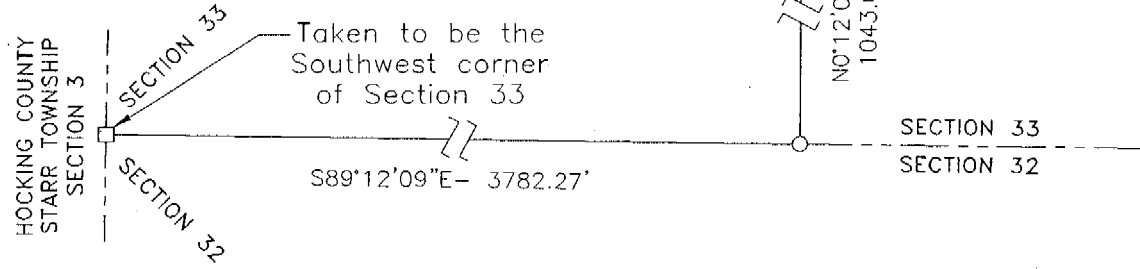
