Thence along the southerly bank of said river the following two courses:
[1] North 44 degrees 44 minutes 29 seconds East a distance of 175.824 feet to a 5/8" iron pin with a plastic identification cap set, and
[2] North 61 degrees 31 minutes East a distance of 1018.853 feet to a point on the east line of River Lot 661;

Thence leaving the southerly bank of the Hocking River and along the east line of said river lot, South 5 degrees 20 minutes 19 seconds West, passing through a 3/4" iron pipe with a plastic identification cap found at 520.91 feet, going a total distance of 939.526 feet to the principal place of beginning, containing 18.5275 acres in Section 35 and 0.8848 acres in Section 36, making a total of 19.4123 acres, more or less, subject to all easements of record.

The bearings used in the above described tract were derived from a previous survey and are for the determination of angles only.
