Situated in the Village of Buchtel, in the southwest quarter of the northwest quarter of Section 6, Town 12 North, Range 15 West, York Township, Athens County, Ohio and described as follows:

Commencing at the northeast corner of Lot 161 in the Village of Buchtel said northeast corner is also THE TRUE POINT OF BEGINNING; thence along the south line of Stephenson Street South 68°28'10" East 12.00 feet to a found iron pin; thence leaving the south line of Stephenson Street South 00°44'23" East 219.40 feet to a point in the center of State Route 78 (passing a set iron pin at 166.23 feet); thence along the center of said State Route 78 South 70°00'38" West 42.37 feet to a point; thence leaving said State Route 78 North 00°44'23" West (passing set iron pins at 54.83 feet, 118.62 feet and 208.61 feet for a total distance of 239.41 feet to a set, on the south line of Stephenson Street; thence along the south line of Stephenson Street South 87°47'09" East 28.93 feet to the point of beginning containing 0.2120 acres there being 0.0066 acres out of Lot 161 and 0.2054 acres out of a tract described in Volume 369 Page 55 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


