Being a Survey of a part of a 5.509 Acre parcel conveyed to Countrytyme Land Specialists, Ltd., as recorded in O.R. Book 618, Page 1668, in the Athens County Deed Records, and being part of Auditor's P.P.N. P01-0010067619, and further described as follows;

Commencing at a stone found at the Southwest corner of the Southeast Quarter of Section 11;

Thence, N 03°55'16" E 1336.74 feet with West line of the Southeast Quarter of Section 11, to a 1" o.d. iron pipe found capped "O.D.O.T." at the Southwest corner of a 3.756 Acre parcel conveyed to The State of Ohio, as recorded in O.R. Book 457, Page 2462, and being on the North line of an 81.24 Acre parcel conveyed to Harold Talbert, Jr., as recorded in Deed Book 335, Page 211;

Thence, S 86°03'34" E 1796.59 feet with the South line of said parcel conveyed to The State of Ohio and extending along the South line of a 47.186 Acre parcel conveyed to Countrytyme Land Specialists, Ltd., as recorded in O.R. Book 615, Page 938, also being the North line of said parcel conveyed to Talbert, to a point, and passing over a 1' o.d. iron pin found capped "O.D.O.T." at 561.12 feet;

Thence, N 03°56'38" E 617.19 feet with an arbitrary line across said 47.186 Acre parcel and extending to a 5/8" o.d. iron pin found capped "Hagan" on the South line of a 1.00 Acre parcel conveyed to Terry M.
