

- 2. North 74 degrees 3 minutes 0 seconds West a distance of 991.45 feet to an iron pin set; thence
- 3. With a curve to the right, having a radius of 1483.00 feet, a long chord bearing of North 60 degrees 3 minutes 10 seconds West, a long chord distance of distance of 635.21 feet and an arc of 640.17 feet to an iron pin set; thence
- 4. North 52 degrees 10 minutes 0 seconds West a distance of 80.57 feet to an iron pin set, taken to be a common corner of said boundary line that is continuous and contiguous between this tract and said 107.24 acre tract as conveyed to Betty J. Cagg, taken to be in the west line of said Fraction 25, taken to be in the easterly line of a 42.2 acre tract as conveyed to the Trustees of the Holiness Camp of the Wesleyan Church and recorded in Deed Volume 302, Page 355;

All iron pins set are 5/8" steel rebar, 30 inches in length with a blue cap marked "Kinnison PS 8231".

Bearings are based upon the South 84 degrees 45 minutes 30 seconds East line (NAD-83, Ohio South) of the north line of Fraction 25 of Section 20, York Township. All other bearings are from angles and distances as measured in the field and tied by GPS to the ODOT CORS stations.

Situated in the State of Ohio, County of Athens, Township of York, being in Fraction 25 of Section 20, Township 12N., Range 15W. of the Ohio Company Purchase (O.C.P.) and being a part of the original tract (Parcel P010010014101 carried as 4.59 acres) as transferred to Betty J. Cagg and recorded in Official Record Book 328, Page 103 and being bounded and described as follows:

Beginning at a stone found with an "X", taken to be the northwest corner of said Fraction 25;

thence with a line taken to be the west line of said Fraction 25, South 4 degrees 49 minutes 58 seconds West a distance of 1053.37 feet to a an iron pin set, taken to be in the west line of said Fraction 25, taken to be in the easterly line of a 4.67 acre tract as conveyed to the Scioto Land Company, LLC and recorded in Official Record Book 392, Page 388, taken to be a common corner of a boundary line that is continuous and contiguous between this tract and a 107.24 acre tract as conveyed to Betty J. Cagg and recorded in Official Record Book 328, Page 103 and being the principle **Point of Beginning** of this survey

- 2. With a curve to the left, having a radius of 1383.00 feet, a long chord bearing of South 59 degrees 56 minutes 39 seconds East, a long chord distance of distance of 594.77 feet and an arc of 599.45 feet to an iron pin set; thence
- 3. South 74 degrees 3 minutes 0 seconds East a distance of 988.53 feet to an iron pin set; thence
- 4. With a curve to the left, having a radius of 2814.00 feet, a long chord bearing of South 79 degrees 39 minutes 25 seconds East, a long chord distance of distance of 382.40 feet and a total arc of 382.69 feet to a mag nail set in the centerline of Carbondale Road (C-1), taken to be a common corner of a said boundary line that is continuous and contiguous between this tract and said 107.24 acre tract, taken to be the northwesterly corner of a 0.75 acre tract as conveyed to Kathy A.
